Amnesty International has learned that Aba Gada and Kenasa, arrested in Chinka on 29 September 1995, were released in late October. The organization has no details of their treatment while in custody.

However, Martha Arero, Fraol Galala and Hailu Gamachu, arrested on 21 September in the southern Ethiopian town of Negelle Borana, are still in Negelle Borana prison. They have appeared in court, but have not been charged and remain held incommunicado for investigation.

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in English or your own language:

- welcoming the release in late October of Aba Gada and Kenasa;
- expressing concern at the continued detention without charge of three other Oromo Relief Association staff Martha Arero, Fraol Galata and Hailu Gamachu
- who appear to be prisoners of conscience;
- appealing for their immediate and unconditional release if they are not charged with a recognizable criminal offence and given a prompt and fair trial;
- requesting guarantees that they are being humanely treated in prison and that they are allowed immediate and regular visits by their families, legal representatives and medical doctors if needed.
