All the opposition party officials and members named above were released in early October. However, the opposition Coalition for Unity and Democracy (CUD), claims that over 800 of its members are still detained in different regions, and says that it will call for peaceful strikes and demonstrations if they are not released quickly. The United Ethiopian Democratic Front (UEDF) opposition coalition has said some of its members in the Oromia and southern regions are still detained. The opposition party members detained may be prisoners of conscience, arrested solely for the non-violent expression of their political opinions.

Hundreds of members and supporters of the CUD and the UEDF had been detained in order to stop them attending nationwide demonstrations which had been planned for 2 October, though the demonstrations were then cancelled. The government accused the parties of planning violence leading up to the demonstrations, though the CUD and the UEDF denied this. Arrests of government opponents on allegations of planning violence are reportedly continuing in some areas. Among those arrested was CUD headquarters official Debebe Eshetu, who was detained on 15 October and held for four days, supposedly in relation to a non-political matter, before being released on bail. Daniel Bekele, a local election monitoring official and a staff member of the non-governmental organization Action Aid, was badly beaten by unidentified armed men on 16 October, apparently on account of his criticisms of the election process.

### **BACKGROUND INFORMATION**

The demonstrations planned for 2 October were in protest at alleged fraud in the parliamentary elections held on 15 May. When Ethiopia's new parliament convened on 10 October, it was boycotted by virtually all the newly-elected 109 CUD members of parliament. The parliament re-elected Meles Zenawi, the Ethiopian Revolutionary Democratic Front (EPRDF) leader, as Prime Minister for a third five-year term. He has announced his new cabinet of ministers.

The parliament stripped the boycotting MPs of their parliamentary immunity. This could place them at risk of arbitrary detention and unsubstantiated criminal charges, as the government and ruling party continue to claim that the CUD is planning violence. The Prime Minister publicly accused the CUD chairperson, Hailu Shawel, of treason, although he has not so far been arrested. The CUD continues to assert its commitment

to non-violent opposition and protest. Several journalists who were arrested in connection with reporting on the elections were provisionally released but may face trial at some time in the future.

Many thanks to all those who sent appeals. Amnesty International will continue to monitor the situation closely and take further action as needed. If possible, please send a final round of appeals to arrive as quickly as possible, in English or your own language:

- expressing concern about reports of the continued detention of opposition party officials and members, and calling for them to be either charged with a recognizably criminal offence or released;
- calling for them to be treated humanely, and given immediate access to their families, legal counsel and medical care;
- appealing for the immediate and unconditional release of those detainees who are prisoners of conscience, held solely for exercising their right to peacefully express their opinions.
