The Ethiopian government has not replied to Amnesty International's appeals and inquiries about the killings and arrests reported in UA 75/94, nor has it issued any statements about them. Amnesty International has, however, received further information.

Reports indicate that **Korad Ahmed Salal** has died in custody and that **Hajio Dama** has been released but is mentally ill on account of torture or ill-treatment. **Dulane Hassan Gabane** has reportedly "disappeared" in detention and there are fears for his safety.

There have been further reports of extrajudicial executions of government opponents in the Ogaden. On 22 February in Wardheer town, government soldiers seeking unsuccessfully to arrest the ONLF general secretary, Sheikh Ibrahim Mohamed Abdallah, shot dead a regional police officer and fired on a crowd of pro-ONLF demonstrators. Troops shot dead some 50 people and injured over 20 others, several of whom later died too, bringing the reported death toll to over 80. Among those listed as dead were **Ahmed Ibrahim Nur**, ONLF regional assembly representative for Wardheer, **Abshir Ali Dhuh**, mayor of Qorilleh, and **Hakin Hersi Abdulleh**, mayor of Addo.

Subsequently there were further mass arrests of ONLF members and supporters in different parts of the region. These included **Ahmed Abdullahi Agooleh**, project manager of the Ministry of Agriculture's South East Rangeland Project (SERP), who was arrested in Godey on 6 April. A former governor of the region who had lost a leg in an assassination attempt against him, he is apparently detained in Jijiga, accused of using his radio to pass out news of the Wardheer killings on 22 February.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- calling for an impartial and independent inquiry into these reports of

extrajudicial executions, and in particular the reports of killings of over 50 civilians by government soldiers in Wardheer on 22 February 1994: the inquiry should take evidence in public, assess whether soldiers used lethal force unlawfully, and report its findings and recommendations publicly;

- calling for guarantees of the safety of those detained, including Ahmed Abdullahi Agooleh and Dulane Hassan Gabane, and investigation into allegations of torture or ill-treatment of detainees and the reported death of Korad Ahmed Salal;
- urging that all detainees be immediately released if they are not promptly taken to a court to be charged with recognizably criminal offences and given fair and early trials;
- appealing for detainees to be humanely treated and given immediate and regular access to their families, lawyers and medical treatment where needed.
