Following demonstrations by school children in late March and April, hundreds more people including Dinkenesh Deressa Kitila and Professor Ephraim Mammo have been arrested. Some of the detainees are being held incommunicado and are at risk of torture. Others may have "disappeared" or could be detained for long periods without charge or trial.

Dinkenesh Deressa Kitila, a production manager for Total Oil company in Addis Ababa and a mother of four children, was arrested in Addis Ababa on 7 June.

Professor Ephraim Mammo, retired President of Alemayehu University in Harar (eastern Ethiopia), former Dean of the College of Veterinary Science, was arrested in the western town of Dembi Dollo in early June, and remains in detention.

Hundreds of Oromos have been detained on suspicion of being Oromo Liberation Front (OLF) supporters. Few detainees have in the past been brought before a court within 48 hours as required by law, and most were never charged even after years of detention. Those who were charged did not receive fair trials. Many of those recently arrested might be prisoners of conscience who did not advocate support for the OLF.

Only a few of those arrested in connection with the student demonstrations have been released - some, for example, in Nekemte town in western Oromia, and several Oromo students from the University of Addis Ababa, were then dismissed from their studies. The government has not so far established an independent inquiry into the killings of several students in the demonstrations. There have been reports of further arbitrary killings of students and others in separate incidents during these arrests.

## FURTHER RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English or in your own language:

- expressing concern for the safety of Dinkenesh Deressa Kitila, Professor Ephraim Mammo and hundreds of others detained as part of a continuing pattern of arrests, connected to the demonstrations in Oromia region;
- calling for investigations into allegations of torture during incommunicado detention or "disappearances";
- calling for the detainees to be given immediate access to their families and legal representatives, any medical treatment they may need and access to an appropriate international humanitarian organization such as the International Committee of the Red Cross (ICRC);
- stating that those detained who are children under 18 should be treated in accordance with Ethiopia's human rights obligations as a party to the UN Convention on the Rights of the Child;
- urging that those arrested be either charged with recognizable criminal offences and given a prompt and fair trial, or released;
- repeating requests for an independent and impartial inquiry into the shootings of demonstrators and others killed during the arrest operation.
