Hassan Jirreh Kalinle and Ahmed Ali Dahir, and three other members of the Region Five Assembly who had been arrested with them in May 1994 and transferred to police stations in Addis Ababa, have been released without having been charged or tried. They are restricted to Addis Ababa.

Mukhtar Aden Gadan, deputy Mayor of Godey - killed

The following members of the Ogaden National Liberation Front (ONLF) who were arrested by soldiers at the same time in eastern Ethiopia are still detained: Omar Mohamed Soyaan (head of the Electoral Commission), Hassan Mohamed Issaq, Abdi Sheikh Omar, Bedel Abdi, Abdifatar Sheikh Mohamoud, Osman Abdi Hassan, Gabon Kenadid, Mohamed Haji Wahdi, Abdimiyir Abar, and Aden Abdullahi.

Amnesty International has just learned that Mirad Leli Sigale, mayor of Godey, who was arrested at the same time, was in fact killed in detention a few days later. Another suspected government opponent, Mirad Sheikh Yusuf, was reported killed at his home on 21 May. In a later incident on about 25 July, another senior regional official, Mukhtar Aden Gadan, was killed by soldiers at his home.

An emerging pattern of human rights violations in "Region Five", including the extrajudicial execution of those held in incommunicado detention has heightened Amnesty International's fears for the safety of all those in military custody in the region, including those named above. Region Five, also known as the Ogaden, and inhabited predominantly by ethnic Somalis, has been a

## RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- welcoming the release of Hassan Jirreh Kalinle, Ahmed Ali Dahir and three other regional assembly members;
- urging that others still detained (naming some from those listed above) are immediately released if they are held solely for their non-violent opinions and have not been taken to court to be charged with a recognized criminal offence;
  expressing fears about detainees' treatment in military custody citing the reported killing of Mirad Leli Sigale and appealing for them to be given
- calling for an independent inquiry into the reported extrajudicial executions of Mirad Leli Sigale, Mirad Sheikh Yusuf and Mukhtar Aden Gadan, and for those responsible to be brought to justice.
