Amnesty International has received further information on the arrest of a number of Rwandese and Burundi nationals in Kenya. The total number of arrests is not known and arrests appear to be continuing. The motive for the arrests is not clear and none of those arrested are known to have been charged. The detainees are held in various detention centres including Muthangari Police Station, Langata Police Station and Kilimani Police Station.

The organization fears that those arrested may be at risk of deportation to Rwanda and Burundi respectively where they could face serious human rights violations on their return.

Refugees from several other countries, including Ethiopia, Somalia, Uganda, Yemen, Nigeria and the Democratic Republic of Congo are also reported to have been arrested. Their names are not yet known to Amnesty International.

Many children are reported to be among the Burundi and Rwandese nationals arrested. Amnesty International has received the names of seven secondary school children and five primary school pupils who are currently detained. At least six other children, including one who is paralysed, are reported to be held. At least one woman was reportedly arrested with her baby.

One Burundian man, Antoine Sinzumusi, was released without charge on 23 July 1997. He had been arrested on 20 July with Jean-Bosco Ntakarutimana, a former Burundi diplomat, and Alexis

Harushukuri. The three were initially reported to be held at Nairobi central prison. However, it appears that Jean-Bosco Ntakarutimana and Alexis Harushukuri are now held at Gigiri Police Station.

Amnesty International has not been able to confirm reports that several other Burundi nationals have been released.

Other Rwandese nationals are reported to have been harassed by Kenyan police officials who have threatened them with arrest and extorted money in exchange for not arresting them. To date, Amnesty International has not received confirmation that detainees have been ill-treated. However, their conditions of detention are described as harsh and some detainees who require medical attention have reportedly only been able to obtain access to a doctor by paying officials in the detention centres.

# FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/ airmail letters in English or in your own language:

- expressing concern that more than 80 Rwandese nationals, at least 30 Burundi nationals and nationals of several other countries are reported to have been arbitrarily arrested since 18 July 1997; mentioning that a number of children are reportedly among those arrested;
- asking for information on the identity of those arrested, their current whereabouts and whether there are any charges against them;
- calling for their immediate release unless they are promptly charged with a recognizably criminal offence and seeking assurances that they are not being ill-treated and have access to medical care, lawyers and visits from their families;
- seeking immediate assurances that they will not be forcibly returned to Rwanda or Burundi where they would be at risk of serious human rights violations.
