Amnesty International has received reports of the arrest in late April 1992 of the people listed above, because of their suspected support for political reform in Malawi. Their present whereabouts are not known. It is likely that they are being held without charge and there are fears that they may be ill-treated.

Mervyn Mapenda, an architect from Blantyre, was arrested on 21 April 1992 because he is alleged to have expressed support for a multi-party political system. George Thaka, who works for a telecommunications company, was arrested at about the same time and probably for similar reasons.

Two Roman Catholic priests from Mzuzu in northern Malawi, whose names are not known to Amnesty International, are also reported to have been arrested recently. This appears to be a reprisal for the pastoral letter issued by the country's Roman Catholic bishops on 8 March 1992, criticizing various aspects of the government's human rights record. (See UA 90/92, AFR 36/06/92, 16 March 1992). Reverend Msowoya, a minister in the Church of Central Africa (Presbyterian) (CCAP), who is also from northern Malawi, is believed to have been arrested because of the support his church has given to the Roman Catholic bishops.

BACKGROUND INFORMATION

Malawi is a one-party state, ruled by the Malawi Congress Party (MCP) which is headed by Life-President Dr H. Kamuzu Banda. No independent political activity or freedom of expression is permitted and detention without trial of government opponents is routine and widespread. The Roman Catholic bishops' pastoral letter was the first public expression of dissent within Malawi since 1964 and has proved to be a catalyst for other criticism of the government, notably from university students. The bishops themselves were interrogated about their letter, which was then declared seditious, and there were public calls for their execution from senior party figures. On 18 April 1992, two Irish Roman Catholic priests were expelled from Malawi, one of them Monsignor John Roche, who was a signatory to the pastoral letter. At about the same time, a South African minister in the CCAP, Reverend Ryk van Veerden, was also expelled from the country.

On 6 April 1992, Chakufwa Chihana, a trade union official who had publicly supported the Roman Catholic bishops and called for an end to the MCP's monopoly of power, was arrested at the airport in Lilongwe as he returned from attending meetings in

Zambia (see UA 114/92, AFR 36/09/92, 6 April 1992 and most recent follow-up AFR 36/13/92, 30 April 1992). On 28 April 1992 the government closed Chancellor College, which is part of the University of Malawi, after student protests. The college had only just reopened. It had been closed in mid-March after student demonstrations in support of the bishops. Amnesty International is concerned about reports that students arrested after the earlier protests were tortured.
