The four prisoners named above who were due to be executed in Chikurubi Maximum Security Prison in Harare on 16 March 1993 have in each case had the sentence of death commuted to life imprisonment.

This decision was taken on 24 June 1993 at the hearing of an appeal lodged in the Supreme Court by the Catholic Commission for Justice and Peace which urged that the sentences of death should be commuted on the grounds that the death penalty violated Zimbabwe's constitution forbidding inhuman punishment. It particularly expressed concern at the length of time which had elapsed since the sentences were passed and the conditions in which the prisoners were held.

After passing its unanimous decision, the Supreme Court also ruled that steps should be taken to improve the procedures relating to the death penalty, in terms of minimizing delays in the hearing of cases and in the appeals procedure.

This is an opportune moment for Amnesty International to call for the abolition of the death penalty in Zimbabwe.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes in English or your own language:

- welcoming the decision taken by the Supreme Court on 24 June 1993 to commute the death sentence in the case of the four prisoners above to life imprisonment;
- stating that the result of the ruling clearly shows that the death penalty is a violation of Zimbabwe's consitution which forbids inhuman punishment and as such should be abolished;
- urging that the Zimbabwe authorities take immediate steps towards reviewing the use of the death penalty in Zimbabwe with a view to implementing its abolition.
