RWANDAJean RUBADAKA Abbé André SIBOMANA Jean-Baptiste BARAMBIRWA

Jean-Baptiste Barambirwa, the president of the human rights organisation CLADHO, was released on the evening of 12 December, apparently as a result of international pressure. He had been held at a gendarmerie station, the "brigade de Remira", in the eastern part of the Rwandese capital Kigali. During his detention, he was interrogated about his speech at the conference on human rights the previous week, in which he had criticised human rights violations in Rwanda. He was not ill-treated in detention. However, his case is still under review by the Public Prosecutor's office. It is not yet known whether he will face any formal charges.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French, English or in your own language:

- welcoming the release of Jean-Baptiste Barambirwa;
- asking the reasons for his detention, and whether he is facing any formal charges;
- appealing to the authorities to put an end to the pattern of intimidation of human rights activists in Rwanda (you can continue to refer to the contents of UA 268/95, 30 November 1995) and asking them to honour their public declaration to protect human rights by ensuring that such activists can operate freely, without fear for their lives.
