Amnesty International is gravely concerned for the safety of Bheki Ntuli and other trade union, as well as African National Congress (ANC), officials in the Esikhaweni-Empangeni area in northern Natal who are potential targets of a hitsquad with links to the KwaZulu police. The hitsquad are believed to have carried out the assassination of Samuel Nyawo on 26 August 1992, as well as the attack on the home of Bheki Ntuli, and possibly other attacks and killings on the same night.

In October 1992 three men were arrested and charged with five counts of attempted murder. Forensic evidence linked the men to the attack on Bheki Ntuli's home. Despite the seriousness of the charges against the three accused, the Mtunzini Magistrate's Court granted them bail, on condition that they report every day to the Esikhaweni police station, which is under KwaZulu Police control. While out on bail the three men have allegedly committed other murders and attempted murders, as well as acts of intimidation against potential witnesses in their trial. On 22 January 1993 lawyers representing Bheki Ntuli and other trade unionists from the Esikhaweni area failed to persuade the court to withdraw bail for the three accused, despite the serious allegations that they had committed further acts of violence while out on bail, as well as failing to adhere to the reporting requirement of their bail conditions. However one of the three accused remained in custody pending a bail hearing on 1 February 1993 in connection with a separate charge of attempted murder.

Since the attacks on their homes in 1992 Bheki Ntuli, Willies Mchunu and other trade union officials have been forced to live in hiding out of fear for their lives. Their testimony will be important in the forthcoming trial of the three alleged hitsquad members. Amnesty International has received reports that a member of the KwaZulu Police and at least one of the accused have threatened to kill them.

# FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in English or your own language:

- expressing concern for the safety of Bheki Ntuli, Willies Mchunu and other trade union officials in the Esikhaweni area of Northern Natal who have had their homes attacked and their lives threatened by heavily armed gunmen, operating apparently with the acquiescence of the KwaZulu Police;
- expressing concern that the men accused of the attack on the home of Bheki Ntuli on 26 August 1992 and charged with five counts of attempted murder have been released on bail;

- urging the authorities to exercise their responsibility to protect the lives of  $\underline{\text{all}}$  South Africans, by making available to them an impartial police force willing to respond promptly to calls for assistance and willing to investigate and arrest the perpetrators of attacks, irrespective of political affiliation.
