UA 61/92 hunger-strike / medical concern

SOUTH AFRICA (Bophuthatswana):

Christopher MAKGALE, on hunger-strike since 18 December 1991 Petrus MOTHUPI, on hunger-strike since 2 January 1992

Amnesty International is concerned about the deteriorating health of the above prisoners on hunger-strike, Christopher Makgale and Petrus Mothupi, particularly in view of reports that they may not be receiving adequate medical attention and are being denied regular access to visits by relatives and human rights monitoring groups.

Christopher Makgale is currently in Odi Prison near Ga-Rankuwa in the nominally independent "homeland" of Bophuthatswana. He is a political activist who is serving a 15-year sentence for murder imposed in October 1991. He began his hunger-strike on 18 December 1991, on the grounds that as a political prisoner he ought to be released under the current program for the release of political prisoners negotiated between the South African Government and the African National Congress (ANC). During his trial the Attorney General of Bophuthatswana reportedly acknowledged that the crime of which he was accused was politically-motivated. Christopher Makgale was admitted to Odi hospital on 28 January 1992, but was discharged on 5 February 1992 and returned to Odi prison, where he is believed to be held in isolation from other prisoners. Members of Bophuthatswana human rights monitoring organizations have not been allowed to visit him in order to monitor his condition on a regular basis, and family visits have also been restricted. He is now on day 69 of his hunger-strike and is reported to be in a very weak condition, unable to walk or to speak above a whisper.

Petrus Mothupi is in Bophelong hospital and has been on hunger-strike since 2 January 1992. He is a member of Umkhonto we Sizwe, the armed wing of the ANC, serving a 15-year sentence for attempted murder imposed in July 1986. He, too, has undertaken a hunger-strike on the grounds that, as a political prisoner, he should be released. On 18 February he was permitted a visit from a lawyer, but requests by human rights monitors to visit Petrus Mothupi regularly have been refused. Visits by his relatives are also restricted. He is now on day 49 of his hunger-strike and is reported to be in a weak condition and to have difficulty speaking.

BACKGROUND INFORMATION:

Following a long-running wave of hunger-strikes by political prisoners in Bophuthatswana between June and November 1991 (see UA 221/91 (AFR 53/23/92, 28 June 1991) and follow ups AFR 53/24/91 (4 July 1991), AFR 53/25/91 (10 July 1991), AFR 53/26/91 (18 July 1991), AFR 53/31/91 (17 September 1991), AFR 53/32/91 (27 September 1991), AFR 53/36/91 (24 October 1991), AFR 53/42/91 (20 November 1991) and AFR 53/43/91, 13 December 1991), approximately 150 prisoners were eventually released, the majority in November and December 1991. During that period, human rights workers attempting to monitor the situation of the hunger-strikers repeatedly expressed concern that hunger-strikers were given inadequate medical monitoring and care, and in some cases were ill-treated by prison warders.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters:

- expressing concern about the deteriorating health of Christopher Makgale and Petrus Mothupi in view of their lengthy hunger-strikes;

- urging that each be granted full access to a medical doctor of his choice and to the treatment prescribed by the doctor, both during the hunger-strike and thereafter, including hospital treatment if recommended;

- appealing for them to be permitted regular visits by their relatives and human rights workers;

- urging that the South African and Bophuthatswana authorities speedily complete their review of the cases of <u>all</u> political prisoners, in order to avoid further suffering to the prisoners and their families.
