UA 140/96 Fear of torture / Possible prisoners of conscience 11 June 1996

SUDANMahjoub al-Zubeir, former president of the Sudanese Workers Trade Union Federation (SWTUF) Yahya Ali Abdallah, former SWTUF secretary general Nasur Ali Nasur, former SWTUF treasurer Awad al-Karim Mohamed Ahmed, trade unionist, engineer Minallah Abdelwahab Eissa, former SWTUF press officer Yahya Saleh Mukwar, medical doctor and former Doctors Union official

These six trade unionists, who have all been active in clandestine opposition trade union activities since independent trade unions were banned in Sudan, were arrested in Khartoum on 4 June 1996. They have not been brought to court or charged. Their current whereabouts are not known but they are believed to be held by the security authorities in secret detention centres known as "ghost houses", where torture of political detainees is common.

All six have been detained previously, particularly in round-ups of leftist and liberal opposition activists, and had been reporting regularly to the security authorities. Dr Yayha Saleh Mukwar has been detained six times before and was last released only in May 1996.

Amnesty International believes they may be prisoners of conscience, arrested for their non-violent opposition to the government, and fears they are at risk of being tortured or ill-treated.

RECOMMENDED ACTION: Please send telegrams/telexes/express/airmail letters in English, Arabic or your own language:

- expressing concern at the detention without charge or trial of these six trade unionists, who may be prisoners of conscience imprisoned for their non-violent opinions and political activities;

asking for assurances that they are not being tortured or ill-treated;
urging that their whereabouts in custody are publicly disclosed, and that they are given immediate and regular access to their families, legal representatives and any necessary medical attention;

- appealing for them to be released immediately unless they are to be promptly charged with a recognizably criminal offence and given a fair and early trial.
