The three men named above were arrested by members of the internal security service on 24 January. They were reportedly severely tortured for the next week, to force them to confess to possessing guns and ammunition, an offence that carries the death penalty. They may soon face a summary trial before the "specialised criminal court", which does not guarantee the rights of defence. They are now apparently held in Adila police station.

Abdallah Hamed Ismail, Mohamed Hamad Adam Muta and Abdallah Mahmud, all from the Ma'aliya ethnic group, were reportedly arrested at Adila market, in Southern Darfur State in western Sudan, at 4pm, and taken to the internal security detention centre in east Adila market. At 5pm they were transferred to the military camp in Adila. At 1am on 25 January six internal security agents reportedly stripped the men and beat them on their backs and shoulders with whips, and tied them up. They then allegedly poured boiling water on the men's backs and burnt them with hot metal objects. This torture reportedly continued over a period of seven days. The three men asked to be taken to hospital, but were refused.

On 2 February they were transferred to the police station in Adila and charged with possessing guns and ammunition. On 5 February the police sent the detainees to Adila hospital for treatment. Medical reports from the hospital are said to confirm the reports of torture. Abdallah Hamed Ismail had reportedly received serious injuries to his back and right eye.

BACKGROUND INFORMATION

Over the past few years there has been an increase of conflict and banditry in Darfur encouraged by the proliferation of small arms and armed militias from nomad groups apparently supported by the government. Armed opposition groups from settled farming communities have taken up arms against government forces and government-supported militias. Among the measures used by the Sudanese government to respond to the increasing violence was the introduction of special courts to deal with offences involving killings, armed robbery and possession of firearms. These courts pass severe sentences, including the death penalty, after summary trials which do not guarantee the rights of defence. In special courts and special criminal courts, confessions, possibly extracted under duress, are accepted as evidence, even when the defendants retract them in court.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English, Arabic or your own language:

- expressing grave concern that Abdallah Hamed Ismail, Mohamed Hamad Adam Muta and Abdallah Mahmud have reportedly been tortured, in violation of Article 7 of the International Covenant on Civil and Political Rights (ICCPR) to which Sudan is a state party, and calling for an immediate investigation;

- reminding the authorities that as a signatory to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment they have committed themselves to the eradication of torture;

- reminding the authorities that torture constitutes an offence under Article 115(2) of the 1991 Sudan Penal Code;

- calling on the authorities to ensure that any members of the Sudan security forces found to have carried out torture are tried in accordance with international standards of justice and fair trial;

- reminding the authorities that, under the Convention against Torture, statements made as a result of torture may not be used in evidence, except against the person responsible.
