SUDAN Samuel Aru Bol

Samuel Aru Bol, a prominent politician from Rumbek District in southern Sudan, is reported to have been arrested in Khartoum on 14 October 1991. He is reportedly held without charge or trial and his place of detention is unknown.

Samuel Aru Bol was arrested after he criticized changes introduced in the education system which affect people in southern Sudan. He is believed to have been detained solely for his peaceful opposition to the policies of the Sudanese government. Amnesty International is appealing for his immediate and unconditional release.

Shortly before Samuel Aru Bol's arrest, the government announced that schools in southern Sudan, as well as those in the north specifically set up for southern Sudanese displaced by the war, were to have Arabic rather than English as their language of instruction.

The issue of Arabic as the language for teaching in secondary and higher education is politically sensitive in Sudan. Historically, English is the language of government in southern Sudan and is the medium of instruction in most southern educational institutions. Tuition in English is regarded by many southern Sudanese intellectuals as protecting their cultural identity in relation to Muslim northern Sudan. Steps to Arabicize the educational system started earlier this year when the government announced that all school-leavers seeking university places would be required to pass an examination in Arabic. Since 1972 southerners have been exempted from this requirement. Southern leaders argued that the requirement discriminated against southern students gaining university places, even at Juba University, which was set up as a university in southern Sudan, but which is now located in Khartoum because of the war.

Samuel Aru Bol, who is 62 years of age and is married with eight children, is a senior politician from southern Sudan. During the government of former President Gaafar Nimeiri, he was Vice-President of the High Executive Council, the government of the autonomous southern Sudan. Following the April 1985 coup against President Nimeiri, he served as Deputy Prime Minister in the Transitional Military Government of President Sowar al-Dahab. Samuel Aru Bol is also the former Chairman of the now banned political party, the Southern Sudan Political Association (SSPA) and former spokesperson of the Union of

Southern African Parties (USAP) formed during the government of Prime Minister Sadiq al-Mahdi. Samuel Aru Bol was arrested with other senior politicians following the military coup of 30 June 1989 and was detained for six months without charge or trial.

## RECOMMENDED ACTION: Telegrams/telexes/express and airmail letters:

- expressing concern about the arrest of Samuel Aru Bol in Khartoum on 14 October 1991;
- requesting assurances that he is being humanely treated;
- requesting information about his whereabouts and urging that he be given prompt access to relatives and legal counsel and any necessary medical attention;
- urging his immediate and unconditional release as he appears to be a prisoner of conscience, detained solely for having peacefully exercised his universally recognized right to freedom of expression.
