UA 195/93 Fear of torture/Incommunicado detention

SUDAN: Adlan Ahmad Abdel Aziz

Adlan Ahmad Abdel Aziz, a 33-year old teacher and reportedly a member of the banned Sudan Communist Party, is reported to have been detained by the security authorities in Khartoum on 12 May 1993. There is serious concern that he may be being subjected to torture. He has not been seen since his arrest and his place of detention is not known.

Political detainees in Khartoum are normally held in the security headquarters or in secret detention centres, commonly known as "ghost houses" in Sudan. However some reports suggest that prisoners have been recently moved from the best known "ghost houses" to other places of detention, apparently to enable the authorities to claim that secret detention centres are not in use.

Detainees are usually beaten on arrival at "ghost houses" and torture during interrogation of prisoners suspected of being active opponents of the government is systematic.

The security authorities deny that torture takes place. However, in one case known to Amnesty International, an elderly prisoner, who the authorities claimed in March 1993 had been freed, was actually beaten to death in December 1992. Camillo Odongi Loyuk, a former southern Sudanese army officer from the city of Juba, was arrested in Khartoum and then tied spread-eagled to the window bars of a room. A cord with a sliding noose was tied around his testicles which tightened if he moved. He was then brutally beaten.

Adlan Ahmad Abdel Aziz was previously detained incommunicado between September 1991 and February 1992. During this period he was badly beaten. It is not clear why he was rearrested in May 1993.

In April and May 1993 the government initiated a major clampdown on suspected opponents in towns and cities across northern Sudan resulting in scores of detentions.

The government, which professes an ideology of militant Islam, has recently stepped up its action against opposition coming from the three major religious orders of traditional Sudanese Islam, the Ansar, the Khatmiya and the Ansar Sunna. The majority of those detained have belonged to these orders.

In May, in the days immediately preceding the 'Id al-Adha, the Muslim holiday marking the end of the period of pilgrimage (hajj) to Mecca, the security authorities confiscated the religious complex centred on the tomb of Mohamed Ahmad al-Mahdi in Omdurman, which is one of the most important shrines belonging to the Ansar. In the days that followed, important mosques belonging to the Khatmiya and the Ansar Sunna were also confiscated.

RECOMMENDED ACTION: Please send telegrams/telexes/express and airmail letters either in English, Arabic or in your own language:

- expressing concern at the arrest on 12 May 1993 of Adlan Ahamd Abdel Aziz;
- expressing concern at his continuing detention without charge or trial and fear that he may be subjected to torture while in an unidentified place of detention;

- requesting assurances that he is being humanely treated, that his whereabouts in custody be made public and that he has immediate and regular access to his family, lawyer and any necessary medical attention;
- urging that he be immediately and unconditionally released unless he is to be charged with a recognizably criminal offence and brought promptly to trial.
