Three leading members of the opposition Civic United Front (CUF) are known to have been arrested and imprisoned solely for the non-violent expression of their political beliefs. Amnesty International considers all three to be prisoners of conscience.

Juma Duni Haji and Machano Khamis Machano were arrested in Zanzibar on 21 February, and charged with participating in an illegal demonstration in Zanzibar town on 27 January. On 23 February they were released but immediately rearrested outside the High Court and charged with the murder of a police officer during a 27 January demonstration in Wete, Pemba island. Neither is believed to have been in Pemba at the time of the demonstrations. They are currently held in Zanzibar Central Prison, but may be moved to Pemba, where they would be at risk of torture. Both men had recently been released after three years as prisoners of conscience, held on fabricated charges of treason. At least 19 other CUF party leaders have also been charged with the murder, even though they and other CUF party leaders were arrested the day before the demonstration and were in police custody at the time of the demonstration. They are now held in Wete prison in Pemba. Among them are Ahmed Seif and his brother Suleiman. Ahmed Seif is a member of the Zanzibar parliament, the House of Representatives. He was tortured after his arrest.

The first four leading CUF officials named above have been freed on bail, together with most of the hundreds of people arrested for taking part in the demonstrations. They could still be tried and imprisoned for participating in an unlawful demonstration. They were severely beaten in police and prison custody, then taken to court and remanded in custody for two weeks on charges of taking part in an illegal demonstration. They were held incommunicado for two weeks, during which they were tortured.

More than 2,000 people, including at least 16 members of the Zanzibar House of Representatives, have now fled to Kenya, and are living in the Shimoni refugee camp near Mombasa.

## BACKGROUND INFORMATION

The Tanzanian security forces began a violent crackdown on the CUF and other opposition parties in late January. Since then an Amnesty International mission has documented systematic torture, including rape and beatings, during and after the crackdown. The security forces are known to have used excessive and

indiscriminate force against civilians during the 27 January demonstrations. Scores of people were reportedly killed in Pemba during the demonstrations, including one police officer. Hundreds were arrested on the mainland, in Zanzibar town and Dar es Salaam.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- saying that Juma Duni Haji, Machano Khamis Machano and Ahmed Seif are prisoners of conscience who should be released immediately and unconditionally;
- asking for assurances that none of those in custody will be tortured or ill-treated, and that they will be given access to lawyers, families and medical treatment;
- urging the government to order an independent and impartial inquiry into the killings and torture during and after the 27 January demonstrations, and to bring those found responsible to justice.
