Human rights defender N'sii Luanda Shandwe is facing charges of treason, following his arrest at home on 19 April. Amnesty International considers the charges to be unfounded and an attempt to censure his human rights work.

N'sii Luanda was transferred to Kinshasa's main prison the *Centre pénitentiaire et de rééducation de Kinshasa* (CRPK), Kinshasa Penitentiary and Reeducation Centre on 26 April. He has been questioned four times since his arrest, particularly about his links with a student known as Bisimwa. The student, who had been lodging at N'sii Luanda's home, was arrested on 8 April and charged with espionage. Bisimwa was apparently found in possession of a list of detainees which had been published by the human rights organisation of which N'sii Luanda is the president: *Comité des observateurs des droits de l'homme* (CODHO), the Committee of Human Rights Observers.

N'sii Luanda is currently detained in the cell-block known as *pavillon 7* at the CPRK. Conditions in this cell-block are better than those at the headquarters of the military tribunal known as the *Cour d'ordre militaire* (COM), Military Order Court, where he was held for the first week of his detention. At the CPRK he is allowed visits from friends and relatives and has access to legal representation.

On 26 April, a *mandat d'arrêt provisoire*, provisional arrest warrant was issued against N'sii Luanda. Under Congolese law, he can be detained for a further 15 days, after which the authorities must provide justification for his continuing detention and seek a court date, or else release him. It is unclear whether his case is still being investigated by the COM or whether it has been transferred to another jurisdiction. The COM has no legal jurisdiction in civilian cases, but frequently brings charges such as treason against detainees in an attempt to justify trying civilians before a military tribunal. Dozens of political activists, journalists, and human rights activists have been imprisoned by the COM after manifestly unfair and politically motivated trials.

BACKGROUND INFORMATION

Last year, N'sii Luanda spent three months as prisoner of conscience at the CPRK. He was held incommunicado in appalling conditions in *pavillon 1* along with some 60 other detainees, who were held for their alleged involvement in the assassination of President Laurent-Désiré Kabila in January 2001. N'sii Luanda was never formally charged throughout his detention and received no explanation, apology or compensation from the authorities after his release.

FURTHER RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in French, English or your own language:

- expressing concern at the continuing detention of N'sii Luanda Shandwe;
- expressing dismay that he has been charged with treason, despite the apparent absence of any evidence of criminal wrongdoing against him;

- stating that you consider him to be a prisoner of conscience, detained because of his human rights activities;
- urging his immediate and unconditional release.
