

For the very first time, human rights organizations from all parts of the Democratic Republic of the Congo have come together to campaign for justice. Your support can help ensure that their voice is heard across the country and at the international level.

Horrific human rights abuses committed by government troops and armed groups have gone unpunished for decades. Although most of the country is now relatively peaceful, there are still areas of fighting in the east and northeast. Here crimes – including killings and mass rapes – continue to be committed with total impunity.

As a new government is being elected, a window of opportunity has opened. The Justice Now campaign is calling for the new government to make reform of the justice

system a priority and to ensure that the interests of victims lie at the heart of the reforms. The campaign is supported by around 100 Congolese NGOs, which together have a presence in every province.

These human rights defenders face daunting challenges, given the chronic incapacity of the national justice system to deal with crimes under international law. Their aim, and ours, is to persuade both the Congolese government and the international community to build a system that brings victims justice, truth and reparations.

Amnesty International is asking its members and supporters to urge the new President to prioritize justice reform, and, just as important, to send a message of solidarity to the Congolese activists struggling for justice.







# WHAT WE CAN DO TOGETHER

In collaboration with the Campaign for Justice, we hope to convince the new government to commit itself to the fight against impunity and to justice reform. We hope to encourage donors to give more attention to neglected areas of the justice system such as victim and witness protection. We hope to see the government providing reparation for the suffering endured by victims.

The Justice Now campaign was launched on 18 November 2011 in Kinshasa and six other provincial capitals, during the national election campaign. Members pressed candidates to make commitments and pledges for justice, and are now following up to see whether those pledges hold good. To influence opinion at the grassroots level, radio, theatre and music will be used from July 2012 to raise awareness of issues such as protection of victims and witnesses, and reparations.

As well as organizing solidarity and support for the Justice Now campaign, Amnesty International is petitioning the President and targeting UN and European Union institutions, which are the main international actors on the ground in terms of justice reform, in New York, Geneva and Brussels.
