DEMOCRATIC REPUBLIC OF CONGON'sii Luanda Shandwe, human rights activist

Human rights activist N'sii Luanda Shandwe has now been held without charge for over 72 hours. Although it is now known where he is held, and it appears that he has not been ill-treated or subjected to further interrogation, he is still at risk of ill-treatment or torture while he remains incommunicado.

Other human rights activists in Kinshasa managed to locate him at a detention centre run by the *Agence nationale de renseignements* (ANR), National Intelligence Agency, on the Avenue des Trois Z in the centre of the city, opposite the Ministry of the Interior. It is one of many unofficial detention centres that the new president, Joseph Kabila, had publicly committed to closing down in March 2001.

N' sii Luanda is said to be in good spirits, and it has reportedly been possible to get some food delivered to him.

The security services had called him in for questioning on 2 and 4 June. During the first interrogation his mobile phone was confiscated, and he was arrested when he went to get it back, on 5 June (not 4 June as given previously). The authorities are reported to have accused him of being in telephone contact with enemies of the state. In fact, the telephone is one of his key means of carrying out his work with the human rights group *Comité des observateurs des droits de l'homme* (CODHO), Committee of Human Rights Observers, of which he is the president.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French, English or your own language:

- expressing concern at the apparently arbitrary arrest and continuing incommunicado detention of $N' \sin Luanda;$
- urging the authorities to allow his lawyers, family and doctors to see him immediately, and to allow him any medical treatment he may require without delay;
- asking what charges, if any, he faces;
- urging them to release him immediately and unconditionally if he is not to be charged with a recognisably criminal offence and promptly given the opportunity to answer any charge before a court of law;
- urging the authorities to implement President Joseph Kabila's public commitment to close all unofficial detention centres, promptly and finally, and to stop targeting human rights activists solely because of their legitimate human rights work.
