## New name: Raphael Wakenge, human rights activist

Raphael Wakenge, a leading member of the human rights organization *Héritiers* de la Justice, was arrested on the evening of 27 August 1999 in Bukavu, South Kivu province. Amnesty International is concerned for his safety.

His arrest is believed to be linked to the arrests of the journalists Mushizi Nfundiko Kizito and Omba Kamengele, who are now detained in Bukavu Central Prison. They were arrested on 25 August 1999 and accused of using their radio receiver to listen to sensitive military transmissions. Amnesty International remains concerned for their safety.

Raphael Wakenge was taken to the Auditorat militaire, military prosecutor's office, for questioning on 27 August, after Mushizi Nfundiko Kizito and Omba Kamengele had been interrogated. He was apparently accused of helping the two journalists to obtain sensitive military information. He was held there overnight and taken to the Central Prison the next day. There are concerns that his arrest might be politically motivated, because of his work as a human rights activist. Raphael Wakenge has been producing human rights programmes on Radio Maendeleo, where Mushizi Nfundiko Kizito and Omba Kamengele work.

Héritiers de la Justice has faced threats from the authorities in recent months. Following their arrest, the governor of South Kivu province accused them publicly of "collaborating with the enemy".

RECOMMENDED ACTION: These appeals are addressed to the Rwandese government, the main political and military ally of the RCD, because Amnesty International has not been able to establish any direct contact with the RCD. Please send telegrams/faxes/express/airmail letters in French or your own language:

- expressing concern about the arbitrary arrest of Raphael Wakenge, leading member of the human rights organization *Héritiers de la Justice*, on 27 August 1999 in Bukavu;
- expressing concern about the arbitrary arrest and detention by RCD soldiers of Mushizi Nfundiko Kizito and Omba Kamengele, respectively Director and Information Officer at Radio Maendeleo, on 25 August 1999 in Bukavu;
- expressing concern that their arrests might be politically motivated because of their work as journalists and human rights activists;
- expressing concern for their safety, since other detainees in the DRC are known to have been severely ill-treated;
- calling on the Rwandese authorities to use their influence with the RCD to ensure the safety of the three detainees, and their immediate and unconditional release, unless they are to be charged with a recognisable criminal offence; calling on the Rwandese authorities to use their influence with the RCD to ensure that Raphael Wakenge, Mushizi Nfundiko Kizito and Omba Kamengele are allowed access to their family, doctors and lawyers of their choice;

- calling on the Rwandese authorities to ensure that their troops and the RCD respect the right to freedom of expression;
- calling on the Rwandese authorities to investigate whether Rwandese soldiers were involved in these arbitrary arrests, and if so, for them to be brought to justice.
