DEMOCRATIC REPUBLIC OF CONGO (DRC) Laurent Kantu Lumpungu, president of the

(Association of Prison Officials)

Prisoner of conscience Laurent Kantu Lumpungu has been held incommunicado and without charge since 29 May 1999.

Amnesty International delegates on mission to the DRC raised their concerns about Laurent Kantu Lumpungu during a meeting with President Laurent Kabila and other government officials on 24 August 1999. Following their meeting the delegates learned that Laurent Kantu Lumpungu's case was to be referred to the *Cour d'Ordre Militaire* (COM), Military Order Court. It is not yet clear whether he has been charged.

The COM is an exceptional court, which offers no recourse for appeal and therefore does not conform to international standards for fair trial. Amnesty International has been campaigning for the reform or abolition of the court, which has sentenced dozens of people to death. The court has been used to try political prisoners and is gradually eroding standard civilian and military jurisdiction. An increasing number of cases are now appearing before this court. Some of those convicted are considered by Amnesty International to be prisoners of conscience. Furthermore, the court has led to a drastic increase in the use of the death penalty.

Laurent Kantu Lumpungu, president of the Association des cadres pénitentiares (Association of Prison Officials) was arrested on 29 May 1999 while on duty at the capital's main prison, the Centre pénitentiare et de réeducation de Kinshasa, (CPRK). He was reportedly whipped after he was taken to the main police station, the Inspection provinciale de la police (IPK). He was later transferred to the CPRK.

FURTHER RECOMMENDED ACTION: Please send telegrams/express/ airmail letters in French or your own language:

-calling for the immediate and unconditional release of Laurent Kantu Lumpungu; -calling for an investigation into allegations of ill-treatment and whippings at the *Inspection provinciale de la police* and for those found responsible to be brought to justice;

-calling for an end to all incommunicado detention in the DRC.
