## ARGENTINADaniel STRAGÁ, human rights lawyer and journalist

On 14 February 1997 an anonymous caller left a telephone message for human rights lawyer Daniel Stragá at his office, indicating that there was going to be an attempt on his life. Amnesty International fears for his safety.

Daniel Stragá works for the non-governmental organization Coordinadora contra la Represión Policial e Institucional (CORREPI), Coordination against Police and Institutional Repression. He is the legal representative for a number of families of victims of police violence, including those killed in circumstances suggesting possible extrajudicial executions and known in Argentina as "trigger-happy" (gatillo fácil) killings.

While Amnesty International is unable to confirm the source of the threat against Daniel Stragá, the organization is concerned that it has occurred in the context of an increasing level of threats and intimidations against journalists (see UA 50/97, AMR 13/01/97, 13 February 1997). As a journalist, Daniel Stragá has received death threats in the past, and in recent years he and a colleague in the legal profession have been subjected to death threats and intimidation on account of their legal work on behalf of victims of police violence [see AI Report 1996].

A complaint about the 14 February threat was filed before a judge attached to the Federal Court No.5 (*Juzgado Federal No. 5*) of Buenos Aires. According to reports, an investigation into the complaint has been initiated by the judge.

## RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in SPANISH or your own language:

- expressing concern at the death threats against Daniel Stragá;
- urging that immediate and effective steps be taken to guarantee his safety; urging that the investigation that has been initiated be carried out thoroughly and conclusively, and urging that its findings be made public and those found responsible for the threats be brought to justice.
