Killed: Martín GONZÁLEZ ZARATE (m), aged 16, son of Lidia ZARATE

Sixteen-year-old Martín González Zarate was shot dead by an unidentified gunman driving by in a vehicle in Buenos Aires province on 16 March. A policeman has reportedly been arrested in connection with the killing.

Martín's older brother, Juan Marcelo, was killed by the police on 19 March 2000. Since then, their mother, Lidia Zarate, has been campaigning for his killers to be brought to justice. The Zarate family has repeatedly been threatened and told to stop their campaign for justice. The police recently told Lidia Zarate to look after her other children, unless she wanted them to end up like Juan Marcelo. In the last year, the police had detained Martín three times. They had reportedly beat him and told him that he would die younger than his brother. He had also been injured in another shooting, where the gunmen had shouted while driving by "this is your mum's fault. Tell her not to mess about with the police" ("esto te pasa por culpa de tu vieja. Decile que no joda con la cana").

Lidia Zarate is a member of the *Comisión de Familiares de Víctimas de Gatillo Fácil*, Commission of Relatives of Victims of Police Shootings, an organization established by a group of parents whose children have been killed by the police. The organization has been campaigning for the truth about the killings to be established, and for those responsible to be brought to justice. Lately, several members of the organization, including those named above, have been intimidated and threatened by the police (see original UA). The killing of Martín González Zarate illustrates the seriousness of the situation, and emphasizes the danger they are in.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or in your own language:

- expressing concern that Martín González Zarate has been shot dead after the police told both him and his mother that he would be killed;
- calling for a thorough and independent investigation to be carried out into the killing, with the results made public and those responsible brought to justice;
- expressing concern for the safety of members of the *Comisión de Familiares de Víctimas de Gatillo Fácil*, including Pedro Ortiz, Mary Ortiz, Lidia Zarate, Delia Garcilazo, Oscar Rios, Silvia Ruiz and Alberto Barreto, whose children have been killed in police shootings, and who have been threatened by the police because of their legitimate campaign for justice;
- urging the authorities to guarantee their safety and that of their families, and to publically recognize the legitimacy of their campaign;
- asking for full and impartial investigations to be carried out into the threats, with the results made public and those responsible brought to justice.
