Amnesty International is seriously concerned for the safety of the two transvestites named above. They were both tortured and verbally abused in two separate incidents by members of the police in the city of Buenos Aires.

In the early hours of 19 October, F.A. Rodríguez was reportedly stopped by a police patrol and asked for her identity documents. She was then beaten up by four police officers who pulled her hair and pushed her to the ground where they continued to hit her around the head. She was then taken to Police Station No. 25 (Comisaria 25) in Buenos Aires, where other police officers joined as the assault on her continued.

F.A. Rodríguez was punched, kicked and hit with a truncheon for approximately one hour. Afterwards, a doctor was called to see her and although she was badly injured, the doctor did not examine her. She was eventually released after several hours, but her identity documents and money were not returned to her. On 25 October, she filed a complaint about her treatment in custody, with the Buenos Aires Ombudsperson and also with the District Court No. 27 (Juzgado de Instruccion No 27) which has powers to investigate such complaints.

In an earlier incident, another transvestite called Nadia Echazú was arrested on 7 October by members of Police station No. 25 in Buenos Aires, as she carried out a street campaign for the Prevention of HIV/AIDS. One of three police officers asked for her identity documents and then spat at her. He also threatened to "break her" if she was found in the area again. She was beaten around the stomach, held by the hair, pushed to the ground and kicked as she lay there. She was then handcuffed, had tear gas sprayed in her face and reportedly insulted by one of the police officers who said "I am going to give you [human] rights, degenerate faggot" ("yo te voy a dar derechos a vos puto degenerado". She was put in a police car and threatened with a gun as she was being taken to the police station. She was subsequently released and on 11 October filed a complaint with the Buenos Aires Ombudsperson.

BACKGROUND INFORMATION

Amnesty International has repeatedly expressed its concern to the authorities at reports of the harassment, death threats, ill-treatment, torture and deaths in disputed circumstances of members of sexual minority groups in Argentina. (See UA 237/00, AMR 13/11/00, 10 August 2000 and follow ups). The authorities still do not adequately investigate reports of ill-treatment and torture by members of the police. In many cases those who report such human rights violations may face reprisals that prevent any criminal complaint from being pursued effectively.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing concern at reports that police officers have tortured F.A. Rodríguez and Nadia Echazú;

- expressing concern for the safety of both F.A. Rodríguez and Nadia Echazú; - urging the authorities to order an independent, impartial and conclusive investigation into the police attacks on both F.A. Rodríguez and Nadia Echazú, and for those found responsible to be brought to justice;
- ask the government to adhere to its commitments to the UN Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment.
