Amnesty International is concerned about the possible extrajudicial execution of Edméia da Silva Euzébio and Sheila da Conceição, killed in Rio de Janeiro, Brazil on 15 January 1993 and for the safety of the other women named above.

Edméia da Silva Euzébio and all the others named above, except Sheila da Conceiçao, are mothers of some of the 11 youths who "disappeared" in 1990 from a farm in Magé, Rio de Janeiro state. They have denounced the kidnappings of their sons and actively campaigned for an investigation to locate them. They have also publicly denounced that members of the military police that patrol the Acari shanty town, favela, where some of them live, have harassed and threatened them (see UA 37/92, AMR 19/01/92, 3 February 1992). On 6 January 1993 Edméia da Silva Euzébio testified in the judicial inquiry on the "disappearance" of the 11 youths and she allegedly denounced the involvement of military and civil police officers in the kidnapping.

According to information received by Amnesty International, in the afternoon of 15 January Edméia da Silva Euzébio and a friend, Sheila da Conceição, were walking in downtown Rio de Janeiro when they realised that they were being followed by two unknown men in a car. The women attempted to run away but the occupants of the car chased them and, after reportedly calling Edméia da Silva Euzébio's name, shot both of them dead. After the killings the men ran back to the car and escaped.

Edméia da Silva Euzébio is the mother of Luiz Henrique da Silva, one of eleven youths (six of whom were minors) abducted on 26 July 1990 from a farm in Magé, Rio de Janeiro, allegedly with the involvement of members of the military and civil police officers, policias civis e militares. According to reports received by Amnesty International, the police officers, hooded and in plain clothes, raided the farm in search of the youths, some of whom were allegedly involved in petty thefts and drug peddling. The abductors took the youths away in two vehicles, one of which was found five days later about 10 kilometres from the farm. The vehicle had been set on fire and blood stains were found on the seat covers. The whereabouts of the youths is still unknown and the case remains under investigation. BACKGROUND INFORMATION

A report by a State Assembly of Rio de Janeiro Parliamentary Commission of Enquiry to investigate the elimination of children and adolescents, published in September 1991, established that most of the killings are carried out by death squads, criminal gangs in many cases made up of off-duty police and military police officers, usually hired by local shopkeepers to "clean up" the area from alleged criminals and petty thieves. Fifty military and civil police officers were allegedly identified as members of death squads.

- urging that the "disappearance" of 11 people in Magé, Rio de Janeiro, on 26 July 1990 be thoroughly investigated, their whereabouts disclosed and those responsible brought to justice.
