BRAZIL: Mariano Domingos FREIRE - Poet and community leader

Amnesty International is concerned about the attempt on the life of Mariano Domingos Freire, poet and community leader, on 10 April 1992 in Matapagipe, Pernambuco, Brazil.

According to the information recently received by Amnesty International, Mariano Domingos Freire was shot and wounded in the face by unknown gunmen near his home in Matapagipe. He was taken to hospital for treatment.

Mariano Domingos Freire is a leader of the <u>Associação dos Pequenos Agricultures de Matapagipe</u>, (Association of Smallholders of Matapagipe). Since 1991, the Association has been demanding compensation for the loss of their land due to the construction of an hydroelectric dam in the region. On the day of the attempt against his life, Mariano Domingos Freire had reportedly attended a meeting with representatives of the firm in charge of the hydroelectric project to settle the dispute.

BACKGROUND INFORMATION

Peasants, members and leaders of rural trade unions and their advisers have been the targets of death threats, assaults, abductions and killings in the context of land disputes in rural Brazil. While Amnesty International takes no position on competing claims in land disputes, it is concerned that gunmen allegedly acting on behalf of landowners have carried out intimidation and killings of peasants, their leaders and advisers with a high degree of impunity.

RECOMMENDED ACTION: Please send telegrams and telexes:

- expressing concern at the attempted murder of Mariano Domingos Freire, leader of the <u>Associação dos Pequenos Agricultures de Matapagipe</u> (Association of Smallholders of Matapagipe);
- urging that an immediate and effective inquiry be carried out into the shooting of Mariano Domingos Freire and that those responsible be brought to justice;
- requesting that immediate steps be taken to ensure the safety of Mariano Domingos Freire.
