Although official information received by AI members indicates that the investigations initiated by the police and the public prosecution service (Ministerio Publico) into the "disappearance" of Marco Antônio Rufino Da Cruz remain open, Amnesty International is concerned at their apparent lack of progress. According to reports, he "disappeared" on 26 November 1994 during a joint army and police anti-crime operation in Rio de Janeiro. It is believed that he was detained by members of the military police. The army and the police have denied having arrested him. No new information has come to light regarding his whereabouts and he remains "disappeared".

The chief of police in charge of the investigation was reported in the Brazilian press as claiming that Marco Antônio Rufino da Cruz was involved in drug-dealing and that he was killed by drug-traffickers. The lawyer working for his family remains concerned that no evidence has been produced to support this claim and fears that he was in fact abducted by members of the military police. Previous attempts by his colleagues to press for information on his whereabouts were reportedly met by anonymous death threats.

There are no reports of renewed threats against Bartolomeu Homem D'El-Rei-Pinto, Rutônio Jorge de Sant' Anna, members of the Civil Servants' Union, and Solange, secretary at the trade union offices. However, all three have stopped making public declarations on the case as a result of the anonymous death threats they received relating to their requests for information on the whereabouts of Marco Antônio Rufino da Cruz.

- expressing concern at the lack of information as to the whereabouts of Marco
  Antônio Rufino da Cruz and the apparent lack of progress in the investigation;
   expressing concern at the campaign of intimidation against those seeking
  information on his whereabouts which has inhibited them from publicly
  expressing their concern for his "disappearance";
- calling on the authoritites to make every effort to establish his fate and to make public any progress in the investigation.
