UA 191/95 Death Threats 1 August 1995

Three public prosecutors at the Military Courts of São Paulo state are reported to have been receiving death threats because of their work to prosecute military police officers implicated in human rights violations.

According to the information received by Amnesty International, the threats are related to the prosecutors' investigations into the "House of Detention massacre" of October 1992 and other crimes committed by members of the military police, particularly the elite battalion known as ROTA (Rondas Ostensivas Tobias de Aguiar). The threats are also reportedly related to the prosecutors' public statements in favour of transferring the jurisdiction of certain human rights crimes from military to civilian courts.

The above-named prosecutors, especially Dr Stella Kuhlmann, have previously received death threats, in 1992 and 1994. However, the threats have intensified since 29 June 1995, when the three met with Justice Minister Nelsom Jobim and were urged by him to speed up proceedings against 120 military police officers and soldiers charged with homicide and other crimes for their participation in the 1992 massacre. According to recordings of the telephone calls, the callers use police-like codes and jargon.

BACKGROUND INFORMATION

On 2 October 1992 a rebellion erupted in the Casa de Detenção prison in São Paulo. Fighting broke out between prisoners who then seized control of Block 9 of the prison. Shock troops of military police stormed the prison to quell the rebellion. When they withdrew 11 hours later, 111 prisoners were dead. Eight separate inquiries into the massacre were established. All found that either "excesses" or "military crimes" had been committed and that most prisoners were killed while defenceless in their cells. The military justice prosecutor has brought charges against 120 military police officers and soldiers for homicide, attempted homicide and grievous bodily harm. The prosecutor described the massacre as "the largest slaughter recorded to date in a single prison in the world [where] detainees' prison sentences were arbitrarily and illicitly turned into death sentences."

Dr Stella Kuhlmann suffered extensive intimidation in 1992, when she and other prosecutors began an investigation into alleged murder and extortion by members of the ROTA military police battalion. In addition to the death threats, a number of bomb threats occurred at the courthouse where the trial members of a ROTA unit was held. The trial resulted in the convictions of two of four police defendants in August 1993.

This is the second case in Brazil in one month where public prosecutors investigating crimes by members of the military police have been threatened with death. In July public prosecutors Mauricio Assayag and José Muiños Piñeiro investigating a massacre by military police officers in Rio de Janeiro reportedly received death threats. In this case the judge in charge of the proceedings, was also threatened (see UA 167/95, AMR 19/13/95, 10 July 1995).

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Portuguese or in your own language:

- expressing concern for the safety of prosecutors Franco Caneva Jr, Fernando César Nucci and Stella Kuhlmann, following death threats against them;
- urging the authorities to take immediate steps to guarantee their physical safety;
- requesting that the threats be thoroughly investigated and those responsible brought to justice.
