COLOMBIA: Edwar ALVAREZ VACCA, aged 20, human rights activist

Amnesty International is concerned at reports of the detention of Edwar Alvarez Vacca, member of the <u>Equipo Coordinadora para la Defensa de los Derechos Humanos de Ocaña</u>, Coordinating Team for the Defense of Human Rights in Ocaña, on 31 January 1991 and believes that he may be a prisoner of conscience.

According to a sworn testimony given by Edwar Alvarez to the <u>personería</u>, ombudsman, of Convención, Norte de Santander department on 1 February, he was travelling in a car with several other people when they were stopped by a military patrol from the army base of La Esmeralda, just outside the town of Convención. Their identity documents were taken to the base and they were searched. The soldiers who had taken his papers asked Edwar Alvarez whether he was the same Edwar Alvarez who was a defender of human rights, which he affirmed. He was then taken to the army base with two others. He states that they were searched again and interrogated by an army officer, who reportedly said to him that the Coordinating Team for the Defense of Human Rights in Ocaña was a front for left-wing political groups and demanded the names of the other members of the Coordinating Team. The men were later taken to the police station in Convención. The same day, a judge came to the police station to take their statements and informed them that they were charged with membership of the armed opposition group Ejército de Liberación Nacional, (ELN), National Liberation Army.

Edwar Alvarez has been actively involved in community and human rights work for a number of years and has been the victim of threats and harassment as a result. In August 1991, the Coordinating Team of Human Rights in Ocaña organized a regional human rights forum in Ocaña which was attended by more than a thousand people, mainly from the surrounding area. Shortly after the forum, the Coordinating Team received an anonymous threat accusing them of being a front for the ELN and saying that they would pay heavily if they did not stop using the Human Rights Coordinating Team for this purpose. Edwar Alvarez believes that he has been detained solely for his human rights work *"estar privado de nuestra libertad por la única razón de ser defensores de nuestras comunidades y de derechos humanos ..."* "the sole reason for our being deprived of our freedom is for our defense of our communities and of human rights". Amnesty International believes Edwar Alvarez is a prisoner of conscience, detained solely on account of his peaceful human rights activities.

FURTHER RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters:

- urging that Edwar Alvarez be immediately and unconditionally released on the grounds that he is a prisoner of conscience detained solely on account of his peaceful human rights activities;

- urging that he be humanely treated while in detention;
- requesting that he be allowed full access to family and lawyers.
