Amnesty International has learned with concern of reports that an Indian community living in Vuelta del Rio, municipality of Ortega, Tolima department, has been the

victim of harassment and threatening behaviour by the Colombian armed forces.

According to reports, on 24 February 1992 approximately 60 soldiers from the Caicedo Battalion, <u>Batallón Caicedo</u>, whose base is in the nearby town of Chaparral, arrived at the Indian community between 3am and 8am. They reportedly caused panic in the community when they carried out searches of many of the Indian's homes without official search warrants, and asked for several members of the community whose names appeared on a list they carried with them, including Anselmo Alape, Vidal Chucuara, Antonio Rodríguez and Raúl Moreno.

There is concern for the physical integrity of those people whose names appeared on the list and for the safety of the community as a whole. Indigenous communities in Colombia have been the victims of serious human rights violations committed by government forces or paramilitary groups whose activities have been supported or tolerated by the Colombian armed forces. These violations sometimes take place in the context of land disputes or against a background of civil conflict (please refer to UA 456/91, AMR 23/72/91 of 20 December 1991 - Massacre of Paez Indians, and UA 514/90, AMR 23/66/90 of 20 December 1990 - Human Rights Violations against Arhuaco Indian leaders).

## BACKGROUND INFORMATION

In September 1991 the Procurator General's office produced an official report which stated that more than 2,300 complaints had been lodged against the army and police in the last two years for human rights violations. President César Gaviria Trujillo, on presenting the report, stated:

"No puede el Gobierno desconocer la gravedad de las acusaciones que se hacen en forma reiterada y masiva contra sus agentes, ni ignorar hasta que punto reina la impunidad por violación de derechos humanos."

constantly and on a massive scale against its agents, nor ignore the extent of impunity in cases of human rights violations".

However, despite the government's commitment to uphold respect for human rights, members of the Colombian armed forces have continued to commit serious abuses, including torture, extrajudicial execution and "disappearance" with virtual impunity.

- expressing concern for the physical integrity of the indigenous community of Vuelta del Rio, including those named above, following harassment and threats against the community by the army's Caicedo Battalion;
- urging an immediate enquiry into these events, the results of which should be made public;
- urging the authorities to protect the physical integrity of indigenous communities and ensure that they are able to carry out their lawful activities without fear.
