Amnesty International is concerned for the safety of Paulino Velandia Barón, Fanny Correa and her son William Correa, following a violent assault on 5 February 1994 on a house in El Cocuy, Boyacá department, by members of the Colombian armed forces. Fanny Correa's husband Edgar Suescan Zambrano and their small daughter Sandra Correa were both killed in the attack.

Paulino Velandia has been the victim of threats and persecution for several years, reportedly by agents of the security forces. At 8 pm on 5 February, as he left a meeting of the town council, he was intercepted by soldiers from the *Tarqui* Battalion, whose base is in Sogamoso. He was searched and his identification card checked. The soldiers reportedly threatened to kill him, warning him that if he escaped on this occasion they would come looking for him in his home and kill him together with his wife and children.

Following this incident Paulino Velandia went to the house where Fanny Correa and Edgar Suescan lived with their two young children, William and Sandra Correa. Soldiers arrived at the house and reportedly forced Paulino Velandia, Edgar Suescan and Fanny Correa to sign sheets of paper which were blank apart from their identification numbers.

Later in the evening, the soldiers reportedly returned. They entered the house, killed Edgar Suescan and Sandra Correa and seriously wounded Fanny Correa and her son William. They threw explosive material into the interior of the house and pursued Paulino Velandia, presumably in order to attempt to kill him too. The immediate reasons for the attack are not clear. Those wounded in the attack are now recovering in hospital. Sources state that their relatives have not been able to see them as they are under permanent police guard. Amnesty International is seriously concerned for their safety and for the safety of Paulino Velandia.

BACKGROUND INFORMATION

In recent years widespread and systematic human rights violations have occurred in Colombia, including extrajudicial executions, "disappearance", torture and arbitrary arrest. Particular targets have been community leaders and members of left-wing parties and trades unions. President César Gaviria Trujillo has repeatedly pledged his government's commitment to protect human rights. However, members of the Colombian armed and security forces continue to commit serious abuses with virtual impunity. Only exceptionally are perpetrators brought to justice; the vast majority of members of the armed forces responsible for gross human rights violations remain in active service.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish or in your own language:

- expressing concern at the reported extrajudicial execution of Edgar Suescan and the minor Sandra Correa, the serious wounding of Fanny Correa and minor William Correa and the threats and persecution of Paulino Velandia which took place on 5 February 1994 by soldiers from the army's Tarqui battalion; - urging that all possible measures be taken by the authorities to protect the lives of Fanny and William Correa and of municipal councillor Paulino Velandia, so that they can carry out their lawful activities without fear; - urging that there be an immediate and thorough investigation into these events, the results of which should be made public and those found responsible brought to justice;

- requesting that relatives be allowed access to those wounded in the attack.
