Colombia: Anniversary of 'Disappearance' of Jairo Bedoya Hoyos

Jairo Bedoya Hoyos has not been seen since 2 March 2000, when he left his son at the *"Urbanización Señorial"* housing estate in Envigadó, municipality of Envigadó, department of Antioquia. Jairo is a member of the *Organización Indígena de Antioquia (OIA)*, Indigenous Organization of Antioquia, which represents indigenous communities in Antioquia department.

As a member of the OIA, Jairo campaigns for the human rights of indigenous communities in Colombia, exposing the human rights violations committed against indigenous peoples. He is involved in the "Para que Embera Viva", "For the Life of the Embera Indigenous People", campaign for the respect of the cultural rights and security of the Embera indigenous community. It is believed that his work in this field led to his 'disappearance' either by the security forces and their paramilitary allies or by guerrilla forces. In recent years, several Embera indigenous communities have been campaigning against the construction of the Urrá Dam in the department of Córdoba in north-western Colombia, which will destroy much of their ancestral lands. Many members of these communities have been victims of serious human rights violations carried out by paramilitary forces working in alliance with the security forces. Guerrilla groups have also been responsible for deliberate and arbitrary killings of indigenous leaders in the same region, accusing them of siding with the paramilitary or security forces.

Many other human rights workers defending the rights of the indigenous communities who are often caught in the middle of Colombia's armed conflict, also face threats and are at risk because of their work.

TAKE ACTION!

1. Write to the Colombian government:

- express extreme concern that a year on from the 'disappearance' of Jairo Bedoya Hoyos of the *Organización Indígena de Antioquia (OIA)* on 2 March 2000 in Envigadó, Antioquia, it appears that no progress has been made in establishing his whereabouts;

- state that, according to information provided by the Colombian government, we know that the case has been referred to the relevant authorities. However the information received does not make clear whether the investigation has opened or advanced;

- urge the authorities to ensure that investigations are advanced and handled preferably by the Human Rights Unit of the Attorney General's Office which has made important advances in investigations of human rights violations in the past and ask to be kept informed of progress in the investigations;

- express concern for the safety of indigenous communities who have reportedly been the victim of human rights violations and violations of International Humanitarian Law by army-backed paramilitaries and guerrilla forces.

- underline your concern that failure to ensure advances into Jairo Bedoya's 'disappearance' suggest the Colombian government is failing to guarantee the security of indigenous communities and the activists which support them in line with repeated UN recommendations;

- state that individual protection measures such as bodyguards and bullet proof jackets are not sufficient to deter the perpetrators of human rights violations against members of human rights organizations, and stressing that genuine efforts to protect human rights defenders must prioritize investigations into killings, as well as threats and harassment, as part of a comprehensive program to prevent more attacks against them;

- urge the Colombian government to adhere to its obligations regarding human rights defenders as laid out in the UN *Declaration on the Right and Responsibility of*
