COLOMBIA: Eduardo AVILA FONSECA, aged 27, political activist

Amnesty International is concerned for the safety of Eduardo Avila Fonseca, who has not been since 20 April 1993 when he was detained in Bogotá by armed men who were reportedly identified as members of the national police.

According to eyewitnesses, Eduardo Avila was last seen at 6 pm on 20 April in the Commercial Sector of Bogotá's Chapinero district, <u>Sector Comercial</u> <u>de Chapinero</u>, at the intersection of the roads *Carrera 13* and *Calle 63*. He was seized by four armed men in civilian dress, who carried police identification and forced him into a taxi, driving him to an unknown destination. His family were informed of his capture in an anonymous telephone call between 8 and 8.30 that evening.

Eduardo Avila is an activist with the legal opposition party M-19 Democratic Alliance, Alianza Democrática M-19 (AD M-19). The AD M-19 was formed in March 1990 when the armed opposition group 19 April Movement, Movimiento 19 de Abril (M-19) disbanded following peace negotiations with the government in which the guerrillas were granted a general amnesty. The AD M-19's leader and presidential candidate in the May 1990 elections, Carlos Pizarro Leongómez, was assassinated a month before the elections took place. Eduardo Avila had been Carlos Pizarro's bodyguard.

Eduardo Avila's detention has been denounced to the office of the Procurator Delegate for Human Rights, <u>Procuraduría Delegada para los Derechos Humanos</u> and to the Procurator General's office, <u>Procuraduría General</u>. His family have made inquiries at local police installations and searched the morgues for his body but there is no information as to his whereabouts.

BACKGROUND INFORMATION

In recent years widespread and systematic human rights violations have occurred in Colombia, including torture, "disappearance" and extrajudicial execution. Particular targets have been members of left-wing parties, community and trade union leaders. The majority of such abuses have been attributed by the Colombian authorities to armed opposition groups or to civilian "death squads" which it claims it is unable to control. However, independent investigations have concluded that many such groups operate under the command or with the support of the Colombian armed and security forces.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish, English or in your own language:

- expressing concern for the safety of Eduardo Avila Fonseca, who has not

been seen since 20 April 1993 when witnesses observed his detention in Bogotá by armed men identified as police;

- urging an immediate and thorough inquiry into his whereabouts;

- urging that if he is in detention, that he be humanely treated and allowed access to lawyers and relatives;

- urging that if in detention, that he be charged with a recognizable criminal offence or released immediately.
