Amnesty International has learned with concern of the killing of Oscar Elias López on 29 May 1992 in circumstances suggesting he may have been the victim of extrajudicial execution.

According to information received by the organization, Oscar Elias López was killed in the town of Santander de Quilichao, Cauca department by heavily armed gunmen on the evening of 29 May.

Oscar Elias López worked as the legal adviser of the Indigenous organization <u>Consejo Regional Indigena del Cauca (CRIC)</u>, the Regional Indigenous Council of Cauca department. He had reportedly received numerous death threats prior to his killing, as have other CRIC lawyers.

The CRIC has been involved in advisory work with the indigenous communities of the northern Cauca area, where many such communities are attempting to recover traditional lands which they claim were assigned and titled to them during the period of Spanish colonization. Some have occupied lands which they claim fall within their reservation, resguardo. Their claims have been disputed by landowners who, with the assistance of paramilitary groups and the support of army and police personnel have often reportedly used intimidatory measures against the Indians in an effort to dissuade the communities from pursuing their claims. Oscar Elias López had been acting as adviser to the communities affected by the massacre, on 16 December 1991, of at least 20 members of the Paez indigenous community. The Indians, who had been occupying a property called "El Nilo" near the town of Caloto, Cauca, were killed by some 60 armed and hooded gunmen who burst into a building where the Indians holding a meeting. Those killed included women and children.

On 8 January 1992 three men who were involved in an independent investigation of the massacre were killed or "disappeared". (Please refer to AMR 23/02/92 of 30 January). Lawyers Carlos Edgar Torres and Rodolfo Alvarez were shot dead at their homes in Cali, Valle department whilst anthropologist Etnio Vidardo "disappeared" from Cali the same night after attending the wake of one of his two friends. His whereabouts remain unknown. At this time the CRIC reported that five of its leaders

had been receiving death threats since the massacre occurred.

Amnesty International had received reports that official investigations initiated by the authorities found evidence that members of the Colombian National Police were implicated in the massacre of the Paez Indians, although the results of these investigations have not yet been made public.

- requesting an immediate and thorough investigation into the killing, the results of which should be made public and those responsible brought to justice;
- continuing to express concern at the killing of Carlos Edgar Torres and Rodolfo Alvarez and the "disappearance" of Etnio Vidardo and asking what steps have been taken to find those responsible and bring them to justice;
- continuing to urge that the results of the official investigations into the killing of 20 Paez Indians from El Caloto on 16 December 1991 be made public and those responsible brought to justice;
- urging that the authorities take all possible measures to protect the lives of all those working with the Paez community and ensure that they are able to carry out their lawful activities without fear of reprisal.
