The dead bodies of three of the 12 Peace Community residents who were abducted by paramilitary forces on 7 April 1999 have been found near Villahermosa, Chocó department. Amnesty International is increasingly concerned for the lives of the remaining nine, named above.

José Angel Cárdenas was the leader of the Villahermosa settlement. Jorge Enrique Murillo and Luis Felipe Lamberti were in the process of joining the community. The three were reportedly tortured before they were killed.

The paramilitary force that abducted the 12 from Villahermosa also reportedly killed Jorge Ramos and his three year old daughter, and injured Oidel Mena, in the nearby settlement of El Arenal. There is still no information available on the subsequent paramilitary incursions into the communities of Caño Seco and Clavellino.

The settlements of Villahermosa, El Arenal, Clavellino and Domingodó, in the dense lowland jungle region of Chocó department, form part of the Peace Community of San Francisco de Asís, whose members have recently been attempting to establish communities closer to the lands they were forced to abandon in 1996 and 1997. The Peace Communities were set up in the northwestern region of Urabá to try and persuade the warring factions to respect their neutrality and their right to life.

Amnesty International is gravely concerned that paramilitary groups operating in the region will carry out their threat to attack other Peace Communities and target community leaders as well as human rights organizations which support the communities.

- expressing grave concern for the safety of Crecencio Mendoza, Jusús Arias, Jerónimo Martínez, Floriberto Hurtado, Raúl Posada, Edgarado Gómez, Joselito Gallego, Miliciades Mena and Jorge Correa who were abducted from the Peace Community of Villahermosa on 7 April 1999 and calling for the authorities to secure their safe release;
- condemning the killing of José Angel Cárdenas, Jorge Enrique Murillo, Luis Felipe Lamberti, Jorge Ramos and his three year old daughter;
- calling for prompt, impartial and full investigations into the abductions and killings, for the results to be made public and for those responsible to be brought to justice;

- expressing concern for the safety of members of the San Francisco de Asís Peace Community in Urabá, especially those living in the settlements of Villahermosa, El Arenal, Clavellino, Domingodó;
- calling the authorities to take immediate steps to protect the civilian population of the region of Urabá, including human rights activists working with the displaced community;
- urging the government to take immediate and decisive steps to dismantle paramilitary groups, in line with their repeated commitments.
