Amnesty International has learned that the seven people named above have been released. They were abducted by paramilitary forces from settlements belonging to the San Francisco de Asís peace community in Chocó department on 7 April 1999.

A Catholic Church commission announced yesterday that the seven community leaders had been delivered into their care by the paramilitary group. The Church commission also expressed their continuing support for the Peace Communities and those working with them.

- welcoming the release of Crecencio Mendoza, Edgardo Gómez, Joselito Gallego, Raúl Posada, Benedicto Moreno, Eleuterio Lemosa and Manuel Rivera;
- expressing continued concern for the safety of members of the Peace Communities in the region of Urabá;
- calling for full, prompt and impartial investigations into the killing of 12 members of the Peace Community of San Franciso de Asís and the abduction of the seven named above by paramilitary forces;
- calling on all parties to the conflict, the Colombian armed forces, paramilitary groups and guerrilla organizations, to respect the neutrality of the peace communities and not undermine their security and credibility through a policy of infiltration.
