COLOMBIA: Gabriel FLOREZ OVIEDO, peasant leader and human rights activist

and two other men (names unknown)

Amnesty International is concerned about reports of the detention of peasant leader and human rights activist Gabriel Flórez Oviedo and two other men by an army patrol in the hamlet of Montebello, in the conflict-torn Magdalena Medio region of Colombia in circumstances suggesting they are at serious risk of torture, extrajudicial execution or "disappearance".

Gabriel Flórez, a regional leader of the Colombian National Peasants' Association, Asociación Nacional de Usuarios Campesinos, and member of the Chucuri Human Rights Corporation, Corporación Chucureña de Derechos Humanos, was detained together with two other peasants (whose first names are believed to be Pedro and Salomon), at 7 am on 22 June 1992 in the locality of Montebello, municipality of San Vicente de Chucuri, department of Santander. According to reports, an army patrol arrived in the village of Montebello and took Gabriel Flórez out of his house by force and drove him and the other two peasants away in a tarpaulin-covered army truck. Relatives of the detained men and members of ANUC went to the local army base where officials denied they were in custody. The whereabouts of the three men remains unknown.

Gabriel Flórez was previously detained for several days by the Colombian army in September 1990 during which time he was repeatedly tortured (UA 367/90, AMR 23/42/90, 14 September 1990). Amnesty International is seriously concerned for the safety of Gabriel Flórez and the two other men.

BACKGROUND INFORMATION

The largely rural area of the Magdalena Medio in central Colombia has been a focus of political violence for several years following the emergence of guerrilla groups in the 1960s and subsequent militarization of the region during the 1980s. The regional human rights committee, Comité Regional para la Defensa de los Derechos Humanos, (CREDHOS), has expressed serious concern about the recent escalation of human rights abuses, including torture, extrajudicial execution and "disappearance" committed by the Colombian army, police and paramilitary organizations working with them, against members of the civilian population in the area.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters:

- expressing concern at the unacknowledged detention of Gabriel Flórez and

two other peasants, by an army patrol in Montebello, Santander department on 22 June 1992;

- urging that they be immediately released unless charged with a recognizably criminal offence;
- urging that they be humanely treated while in custody and that they be allowed full access to family and lawyers.
