COLOMBIA: Members of Regional Human Rights Committe (CREDHOS) in Barrancabermeja

new name: Julio César BERRIO VILLEGAS - Human rights worker

Amnesty International has learned with concern of the killing Julio César Berrio Villegas on 28 June 1992 in Barrancabermeja, Santander department. Julio César Berrio, was the third member of the Regional Human Rights Committee (CREDHOS), Comité Regional para la Defensa de los Derechos Humanos, to have been killed in the last 16 months. Several other members have escaped attempts on their lives and have been repeatedly threatened by paramilitary groups.

Julio César Berrio had worked for CREDHOS for two years as a security guard protecting the Committee's offices. He had also recently been involved in investigating killings in Barrancabermeja attributed to paramilitary groups. At 5 pm on 28 June 1992 he was shot dead by two unidentified gunmen in an ice-cream parlour in Barrancabermeja. His wife witnessed the shooting.

In March 1991 CREDHOS worker Humberto Hernández was shot dead in Barrancabermeja by men in civilian clothes. In January 1992 CREDHOS' secretary Blanca Valero de Durán was killed outside the Committee's office by gunmen in civilian dress (see UA 34/92, AMR 23/03/92 of 31 January 1992). Three policemen who witnessed the attack reportedly ignored her cries for help and made no attempt to pursue her assailants, who remain at large.

Following statements by local military commanders in February 1992 linking CREDHOS to guerrilla organizations, threats from paramilitary forces increased. In June three CREDHOS members, including the President, lawyer Jorge Gómez Lizarazo, narrowly escaped injury when their cars came under sustained fire from several heavily armed men. Although the Colombian government has condemned the attacks on CREDHOS and has promised full investigations, those responsible have not yet been identified and brought to justice.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters

- expressing serious concern at the killing of Julio César Berrio Villegas and at the continued attacks against CREDHOS members;
- urging that there be an immediate and thorough inquiry into the death of Julio

César Berrio Villegas and other attacks against CREDHOS members, the results of which should be made public;

- urging that those responsible for the killings and threats against CREDHOS members be brought to justice;
- welcoming government statements condemning attacks against CREDHOS members and requesting the Colombian authorities to take measures to guarantee that human rights workers are able to carry out their lawful activities without fear of reprisal.
