COLOMBIA: Hugues LOPEZ, teacher

Amnesty International is concerned for the safety of Hugues López, a teacher, whose life has reportedly been threatened by members of the Colombian armed forces.

According to reports, Hugues López, who lives with his family in the town of Convención, Teorama municipality, Norte de Santander department, was at home on 13 July 1991 when three men, armed but wearing civilian clothing, arrived at his house and asked for him by name. When he came to the door, they asked if he was a teacher. Upon replying that he was, one of the men pulled a gun on him. Hugues López fled and managed to escape through his neighbour's house, pursued by the armed men, who then proceeded to search his house and that of his neighbour. The men did not identify themselves at any time, but were recognised by people from the town as soldiers from the nearby army base of the Rook Battalion, Batallón Rook.

Following these incidents, Hugues López has had to leave his job and his home and is currently in hiding. There is also concern for the safety of his family, still living in Convención.

**BACKGROUND INFORMATION** (Notes to translators: please refer to UA 136/91 for similar background information)

In recent years, widespread and systematic human rights violations have occurred in Colombia. Counter-insurgency operations by the Armed Forces have been progressively intensified to combat the country's guerrilla groups. In areas where guerrilla forces are active, the local civilian population is often perceived by the armed forces as potential collaborators and has, as a result, been subjected to threats and harassment, arbitrary arrest, torture, "disappearance" and extrajudicial execution by army personnel and civilians working for them. Civic leaders and community workers and people associated with legal left-wing parties have been particular targets.

# RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters:

- expressing concern for the safety of Hugues López following the attack on his life, apparently by members of the Colombian armed forces;
- asking that an immediate investigation be initiated into this attack and that those responsible be brought to justice;
- asking that the necessary steps be taken to ensure his safety and urging the authorities to take measures to protect the lives of teachers to ensure that they can work without fear.
