## COLOMBIAAndis VILLALOBOS GALAN (f)]abducted Yaser LARIOS VILLALOBOS (infant)]

#### Civilian population of San Martin de Loba, Sur de Bolivar

A mother and her infant son have been abducted by army-backed paramilitaries who were searching for her husband and brother-in-law. They are reportedly being held at a nearby paramilitary base. Amnesty International is seriously concerned for their safety.

On 2 June 2000 a group of more than 100 paramilitaries entered the village of Pueblo Nuevo Mejía in the municipality of San Martín de Loba, Sur de Bolivar, in search of Omar Larios Fernandez and his brother, Eduard Larios Fernandez. Both had fled the town. Five paramilitaries then abducted Ana Galan de Villalobos, her daughter Andis Villalobos Galan, who is married to Omar Larios Fernandez, and their infant son, Yaser Larios Villalobos. They were taken to a paramilitary base in the municipality of Barranco de Loba, Sur de Bolivar. Ana Galan de Villalobos was freed later that day. It is reported that Andis Villalobos has been ill-treated and may have been threatened with sexual abuse and is being forced to cook for the paramilitaries.

The authorities have failed to take action against paramilitary forces in the area, and this is putting civilians, including community leaders at great risk of further attacks.

### BACKGROUND INFORMATION

There have recently been several paramilitary incursions in the region despite a large army presence. In the week of 5-10 June 2000, paramilitaries reportedly entered several towns in the municipalities of Morales and Santa Rosa in Sur de Bolivar, and threatened the civilian population. Amnesty International also received reports that between 21-26 April 2000 a group of 400 paramilitaries was active in Cerro Azul, in the municipality of San Pablo in southern Bolivar department (see UA 100/00; AMR 23/29/00; 28 April 2000).

Members of the Colombian army and security forces and their paramilitary allies commit serious human rights violations with virtual impunity. Paramilitary groups have killed several thousand civilians in the last five years. The Colombian government suspended the constitutional legal base for the formation of paramilitary organizations and issued directives to the armed forces to combat and disband such groups in 1989, yet they continue to work with the support of the security forces in many areas of the country.

Guerrilla forces have also committed serious violations of international humanitarian law, including executing those they accuse of being security force or paramilitary force collaborators.

calling for the authorities to take immediate action to secure the release, unharmed, of Andis Villalobos Galan and her infant son, Yaser Larios Villalobos, who were abducted on 2 June 2000;

calling for full and impartial investigations into the abduction of Andis Villalobos Galan and her infant son, Yaser Larios Villalobos;
expressing concern for the safety of civilian inhabitants of the municipality of San Martín de Loba, Sur de Bolivar and urging that all steps deemed necessary by themselves are taken to guarantee their safety;

- calling for a full and impartial investigation into links between the security forces and paramilitary groups operating in the municipality of San Martín de Loba, Sur de Bolivar, urging that the results are made public and those found responsible for supporting and participating in such groups are brought to justice;

- urging the authorities to take immediate action to dismantle paramilitary groups, in line with stated government commitments and United Nations recommendations.
