Trade Union activist Roberth Cañarte Montealegre was abducted on 29 June 2000 by paramilitaries of the *Autodefensas Unidas de Colombia* (AUC), United Self-Defense Groups of Colombia, in the south-western department of Valle del Cauca. Amnesty International is seriously concerned for his safety and for that of other trade union activists in Valle del Cauca following threats and intimidation from paramilitary forces in the area.

Roberth Cañarte Montealegre is an active member of the SINTRAMUNICIPIO union. On 31 January 2000 the president of SINTRAMUNICIPIO and founder of the CUT *Sub-directiva Valle del Cauca*, Trade Union Confederation - Valle del Cauca branch, Orlando Crespo C. was killed, apparently by the AUC.

On 8 February 2000 the following text was included in a letter, signed by the AUC, which was sent to trade union offices: "...Los acusamos de ser marionetas de la guerrilla... por lo tanto desde ahora son declarados objetivos militares. Objectivo: Cumplir las ordenes de nuestra comandancia." ("...We accuse you of being guerrilla .. Therefore from now on you are declared military targets: Objective: To carry out the orders of our command")

Between April and June 2000 a number of trade union leaders in the region received anonymous threatening telephone calls giving them a fixed time in which to leave the city or be "sentenced to death".

On 25 May 2000 some 50 signs appeared in the City of Cali, twelve of which accused SINTRACMCALI workers of being guerrillas: "Fuera guerrilla de Emeali y de Cali. Guerrilleros Asesinos." ("Emeali and Cali guerrillas get out. Guerrilla murderers.") These signs reportedly remain in place.

In June 2000 Gilberto Agudelo Martínez, National President of SINTRAUNICOL, the Colombian University Workers and Employees Union, and a leader of the CUT "disappeared" (see UA 158/00; AMR 23/46/00; 13 June 2000). His whereabouts remain unknown.

On 8 June 2000 the president of the Sindicato de Trabajadores del municipio de Yumbo, Elver Alberto Granja, was sent a bomb by post to the union office. The bomb was diffused.

Amnesty International has received reports that unidentified people are now watching the offices of the SINTRAEMCALI union and the houses of leading SINTRAEMCALI activists.

These are just the latest incidents in a sustained attack against trade unionists in the south-western region of Colombia since July 1999 when the AUC declared that they were beginning to operate in the area.

## BACKGROUND INFORMATION

For many years the security and armed forces and their paramilitary allies have accused trade unionists, human rights workers, members of legal opposition groups and popular activists of being guerrilla sympathizers or auxiliaries. The people they have accused have frequently been harassed, tortured and killed, often by paramilitaries. The International Confederation of Free Trade Unions Annual Survey for 1999 recorded that during the previous year more than 90 trade unionists had been murdered in Colombia.

Amnesty International has documented systematic persecution of trade unionists in Colombia. Seven trade union leaders were shot dead during the 1998 national strike, including CUT vice-president Jorge Ortega Garcia (see UA 274/98, AMR 23/80/98, 21 October 1998, and follow up, AMR 23/90/98, 24 November 1998). None of these crimes has been resolved and those responsible have not been brought to justice.

# RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

- expressing concern for the safety of Roberth Cañarte Montealegre who was abdueted on 29 June 2000 and for other trade union activists in Valle del Cauca;
- urging that there should be a full and impartial investigation to establish the whereabouts of Roberth Cañarte Montealegre and make all efforts to secure his immediate release;
- urging that those responsible for his abduction be brought to justice;
- asking the authorities what measures they are going to take to guarantee the safety of those at risk;
- urging that the authorities take immediate action to dismantle paramilitary groups, in line with stated government commitments and recommendations made by the UN and other intergovernmental organizations.
