Civilian population of La Pedregosa, Santa Catalina and other communities of the municipality of Cajibío

The paramilitary forces who abducted Matías Zambrano and José Justo Zambrano on 16 March are consolidating their position in the municipality of Cajibío. The people of Cajibío have repeatedly asked the authorities to take action against the paramilitaries, but they have done nothing.

On 11 May paramilitaries went into five communities: San José (part of El Carmelo) and El Cidral, Jalaya, San Antonio and Santa Catalina (part of La Pedregosa). Soldiers from the regular army reportedly went into La Pedregosa at the same time.

On 19 May the paramilitaries were reportedly still in the area, and local people are seriously concerned that they are preparing to kill people in the communities, despite the presence of the army.

Army units stationed very nearby have been told repeatedly about the paramilitaries active in the region, but have reportedly done nothing to confront them. Soldiers from these units have reportedly accused local people of being guerrilla collaborators, and in the past such accusations have frequently been followed by serious human rights violations.

The army units are from the *Brigada III*, (III Brigade), from the *Batallón Contraguerrilla No3 de Numancia* (Numancia Counter-guerrilla Battalion No.3) and the *Batallón de Infantería No.7 General José Hilario López* (General José Hilario López Infantry Battalion No. 7).

There is no news of Matías Zambrano and José Justo Zambrano, who were abducted by paramilitaries on 16 March in Santa Catalina.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or in your own language:

expressing concern for the safety of civilians in the municipality of Cajibío, including the inhabitants of La Pedregosa and El Carmelo, following reports that paramilitaries are consolidating their position in the municipality; - urging the authorities to take appropriate measures to protect the civilian population, and reminding them that if they fail to do so, it will seem that the paramilitaries are operating with the complicity of the security forces; - calling for a full and impartial investigation into links between the security forces and paramilitary groups operating in Cauca Department, urging that the results are made public and those found responsible for supporting and participating in such groups are brought to justice;

- urging the authorities to take immediate action to dismantle paramilitary groups, in line with stated government commitments and United Nations recommendations.
