Amnesty International continues to be seriously concerned for the safety of trade union leaders and activists in Colombia, after a written death threat was sent to three leading members of the *Federación Unitaria de Trabajadores de Antioquia* (FUTRAN), United Workers' Federation of Antioquia. The message was sent to FUTRAN's headquarters in Medellín, department of Antioquia, earlier this month.

The message was signed by paramilitary groups calling themselves Autodefensas Unidas, United Self-Defence Groups, and COLSINGUE, the acronym of the paramilitary group Colombia sin Guerrillas, Colombia without Guerrillas. In the note, the paramilitaries warned that they had "resuelto asesinar a los tres guerrilleros que hay allí enmascarados", "decided to kill three guerrillas who are working there undercover". The three "guerrillas" the note refers to are: Jesús Alfonso Ruiz, FUTRAN's internal supervisor; Amparo Echevarría, FUTRAN's Secretary General and Guillermo Cárdenas, FUTRAN's Vice-President.

Concern for the safety of trade union activists in Colombia has been heightened by the recent death threat against the *Unión Sindical de Obreros* (USOO, Worker's Trade Union, and the *Central Unitaria de Trabajadores* (CUT), United Confederation of Workers' Leaders, and by the killings, attempted killings and death threats suffered by FUTRAN members during 1994 (see FU UA 295/94, 26 Aug 94; UA 299/94, 12 Aug 94; UA FU 299/94, 30 Sep 94; UA 376/94, 13 Oct 94).

# FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in Spanish or in your own language:

- expressing extreme concern for the safety of Jesús Alfonso Ruiz, Amparo Echevarría and Guillermo Cárdenas following recent death threats against them;
  calling for a full and impartial investigation into the threats, asking that the results be made public and that those responsible be brought to justice;
  urging that all possible measures be taken to protect the lives of other trade unionists in Colombia;
- urging the authorities to take immediate steps to dismantle paramilitary groups in line with stated governmental commitments.
