Other members of Embera-Katío indigenous communities living along the rivers Sinú and Verde in the department of Córdoba

Another indigenous leader has reportedly been abducted and murdered by army-backed paramilitaries, after he campaigned for the safe return of Kimy Pernia Domico. The Embera-Katío communities of Córdoba department are in great danger.

Pedro Alirio Domicó was the governor of the Resguardo Indígena del Río Esmeralda, Esmeralda River Indigenous Reserve, in Tierralta municipality. He took part in an indigenous demonstration in Tierralta, demanding the safe return of Kimy Pernia, who was abducted on 2 June. He had been among a group of indigenous leaders who met with the Minister of the Interior and the Governor of Córdoba, to discuss action by the authorities to protect the Embera-Katío communities in Córdoba.

Pedro Alirio was reportedly abducted by the Autodefensas Unidas de Colombia (AUC), United Self-Defence Forces of Colombia, during the weekend of 23-24 June. His body was reportedly found on 26 June in Tierralta. Before he was killed, he had been accused of collaborating with guerrilla forces. Others accused of collaborating with the guerrillas have frequently been abducted or killed by the security forces and their paramilitary allies.

In recent years, several Embera-Katío indigenous communities campaigning against the construction of the Urrá Dam, which will destroy much of their ancestral lands, have been targeted by paramilitary forces working in alliance with the security forces. Community leaders have also been killed by guerrilla forces, who have accused them of siding with the paramilitary or security forces.

There is no further news of Kimy Pernia.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

- expressing concern at the news that indigenous leader Pedro Alirio Domico has been killed, apparently by army-backed paramilitaries, and urging the authorities to order a full and impartial investigation into the killing, with the results made public and all those responsible brought to justice;
- expressing concern for the safety of Kimy Pernia Domico, who has "disappeared" since he was abducted on 2 June;
- calling for a full and impartial investigation to establish his whereabouts, and asking for him to be released immediately, if he is in custody;
- urging that those responsible for his abduction be brought to justice;
- expressing concern for the safety of other members of the Embera Katío communities along the rivers Sinú and Verde, urging that all measures deemed appropriate by the communities themselves are taken to guarantee their safety from paramilitary or guerrilla attack;
- urging that all those responsible for killings or "disappearances" in the area be brought to justice;
- calling for a full and impartial investigation into links between the security forces and paramilitary groups operating in Córdoba Department, urging that

the results are made public and those found responsible for supporting and participating in such groups are brought to justice;

- urging the authorities to take immediate action to dismantle paramilitary groups, in line with stated government commitments and United Nations recommendations.
