COLOMBIAPedro Julio MAHECHA AVILA

Since October 1996, Pedro Julio Mahecha and his family have been subjected to intimidation and harassment by persons believed to be members of the Colombian security forces. Amnesty international is seriously concerned for their safety.

Pedro Julio Mahecha works on cases of human rights violations perpetrated by the Colombian security forces, for the lawyers' collective, *Corporación Colectivo de Abogados José Alvear Restrepo* (CCA). The CCA reports a series of intimidatory incidents directed against Pedro Julio Mahecha and his family since October 1996. Pedro Julio Mahecha reported that he and his family were being followed by unidentified individuals and that colleagues were receiving anonymous telephone calls attempting to establish their whereabouts.

The CCA is working on numerous important cases of human rights violations in Colombia in which members of the police and army are implicated and its lawyers have in the past been subjected to death threats and harassment because of their work (see UA 297/93, AMR 23/51/93, and UA 108/94, AMR 23/28/94, and previous UAs relating to this case).

BACKGROUND INFORMATION

Human rights defenders in Colombia have in recent years been facing increasing harassment and intimidation which in some cases has been followed by attacks on their lives. On 13 October 1996 Josué Giraldo Cardona, President of the *Comité Cívico por los Derechos Humanos del Meta*, Meta Civic Human Rights Committee, was shot dead outside his home after receiving numerous death threats (see follow-up to UA 68/95, AMR 23/52/96, 15 October 1996).

On 9 September 1994 President Ernesto Samper Pizano, who took office on 7 August, declared in a speech that his government "would seek to have constructive relations with human rights organizations with the aim of suppressing human rights violations and would do everything necessary to protect the lives and integrity of human rights workers. ["Buscará sostener con los organismos de derechos humanos relaciones constructivas en procura de suprimir las violaciones de tales derechos y pondrá de su parte cuanto sea necesario para proteger la vida y la integridad de sus miembros."] Amnesty International calls upon President Samper to stand by his commitment and ensure that the members of the CCA and all other human rights workers can carry out their lawful activities without fear for their own lives or those of their families.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or in your own language:

- expressing concern for the safety of human rights lawyers working for the *Corporación Colectivo de Abogados José Alvear Restrepo (CCA)*, in particular Pedro Julio Mahecha, following reports that he is again being intimidated, allegedly by members of the Colombian security forces;
- urging that these reports be investigated, the results made public and those responsible brought to justice;

- urging that concrete measures, deemed appropriate by those concerned, be taken to protect their lives and those working for the CCA and their families in line with the commitment made by President Samper to ensure the safety of human rights workers.
