Amnesty International has learnt with extreme concern of the killing of Jesús Antonio Montoya, a lawyer and founding member of the Solidarity Committee with Political Prisoners (*Comité de Solidaridad con los Presos Políticos - CSPP.*) on 14 December 1993 in Cali, Valle del Cauca department. This killing further heightens Amnesty International's fear for the safety

This killing further heightens Amnesty International's fear for the safety of others working for the protection of human rights in Colombia.

According to reports, Jesús Antonio Montoya was arriving at a meeting with a Housing Committee in Barrio Navarro in the Belalcázar neighbourhood of Cali, when two unidentified gunmen stopped him in the doorway. There was an argument during which he was injured. He managed to get away to a nearby shop, but the gunmen returned, shooting him 14 times in the chest. The gunmen fled on a motorbike taking with them Jesús Antonio Montoya's briefcase containing many documents.

Jesús Antonio Montoya worked as a lawyer, defending many different trade union organizations and political prisoners. He also represented a group of trade unionists claiming compensation from the state for their arbitrary arrest, torture and imprisonment by the army's III Brigade in Cali in 1990. Another of the unionists' lawyers, Alirio Pedraza Becerra, "disappeared" in July 1990 and his whereabouts still remain unknown. Jesús Antonio Montoya was also an active member of the Communist party (*Partido Comunista*) and the Patriotic Union Party (*Unión Patriótica*).

# BACKGROUND INFORMATION

In recent years widespread and systematic human rights violations have occurred in Colombia, including torture, arbitrary arrest, "disappearance" and extrajudicial execution. President César Gaviria Trujillo has repeatedly pledged his government's commitment to protect human rights. However, members of the Colombian armed and security forces continue to commit serious abuses including extrajudicial executions and "disappearances" with virtual impunity. Civic leaders, trade unionists and human rights activists are amongst the groups frequently targeted by the security forces for arbitrary arrest and other forms of human rights abuse.

# RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish, English or in your own language:

expressing concern about the killing, in circumstances suggesting he may have been extrajudicially executed, of Jesús Antonio Montoya Ospina by unidentified gunmen in Cali, Valle del Cauca department, on 14 December;
urging that there be an immediate inquiry, the results of which should be made public and that those found responsible be brought to justice;

- urging that the government take all possible measures to protect the lives of other human rights activists so that they can carry out their lawful activities without fear.
