The shooting, on 14 December 1999, of human rights lawyer William Bedoya in the city of Barrancabermeja, department of Santander, has raised concern for the safety of other human rights defenders in the city.

Amnesty International is particularly concerned for members of the *Corporación Regional de Derechos Humanos* (CREDHOS), Regional Human Rights Corporation and *Asociación de Familiares Detenidos y Desaparecidos* (ASFADDES), Association of the Relatives of the Detained and Disappeared. Both organizations have recently been threatened, harassed and intimidated, including computer records being stolen from the CREDHOS offices and a failed attempt on the life of its director in March (see UA 277/99, 21 October 1999 AMR 23/74/99).

William Bedoya, who works with political prisoners and has reportedly been threatened with death before, apparently by paramilitary groups operating in the area, was shot by two gunmen as he was leaving his house in Barrancabermeja. He is now in intensive care in hospital.

Human rights lawyers who represent political prisoners have often been labelled as subversives by the security forces and their paramilitary allies and been the target of serious human rights violations.

## BACKGROUND INFORMATION

The policy by the security forces and their paramilitary allies of labelling human rights organizations, particularly those seeking to uphold the legal rights of people accused of "subversion", as guerrilla collaborators or supporters means they are able to present them as legitimate targets in the counter-insurgency war. This has resulted in an increasing number of serious human rights violations by the security forces and their paramilitary allies against human rights defenders - over 20 have been killed or "disappeared" in the last two years. Some armed opposition groups also refuse to respect the legitimacy and independence of organisations which belong to civil society.

On 9 September 1999, Colombia's Human Rights Day, President Andrés Pastrana issued Presidential Directive No 07 concerning 'support, communication and cooperation of the Colombian State with human rights organizations'. The Directive orders all public officials to abstain from questioning the legitimacy of human rights organizations and from making false accusations which could compromise their security or reputation.

## RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

- expressing alarm at the shooting of human rights lawyer William Bedoya in Barrancabermeja on 14 December 1999;
- expressing concern for the safety of other human rights defenders in the  $\operatorname{city}$ ;

- urging the authorities to undertake all measures deemed appropriate by those under threat themselves, to guarantee their safety;
- urging the authorities to carry out a full and impartial investigation into the shooting of William Bedoya, to make the results public and to bring those responsible to justice.
