COLOMBIAForcibly displaced civilian communities of the Cacarica River Basin area and other displaced communities in the department of Chocó

Army-backed paramilitaries have arrived in the Cacarica River Basin (*Cuenca del Cacarica*) area in force, and have begun attacking communities there and in the surrounding area. The inhabitants had been forced to flee their homes in 1997, but recently returned to resettlement camps.

On 28 November a group of 100 armed men believed to be paramilitaries came to the Villa Hermosa-La Raya area, part of the community of the Cacarica River Basin. They opened fire on one of the houses with an M-60 heavy machine gun. The peasant farmers took cover in the cornfields, and reportedly saw the gunmen ransacking all the houses in the settlement and then setting fire to five of them. The paramilitaries reportedly burnt the settlement's store of approximately 16,000 kilos of rice (which would have fed them for six months) and took with them the community's work papers, identity documents and 900,000 pesos (US\$430). They reportedly left a note at the entrance to each house inviting the peasant farmers to give up their civilian status and join them.

These paramilitary incursions coincide with further death threats against members of the Peace Community of San José de Apartadó in neighbouring Antioquia Department.

On 23 November soldiers from the XVII Brigade stopped a young girl from the Peace Community of San José de Apartado at a checkpoint 10 minutes' walk from the community. With them was a man in a balaclava, believed to be a member of a local army-backed paramilitary group. He apparently told the soldiers that she was a guerrilla, and when she denied it one of the soldiers told her: "No mienta. Toda la gente de por aquí es guerrillera. Esa Comunidad de Paz es pura guerrilla." ("Don't lie. Everyone around here is a guerrilla. The Peace Community is pure guerrilla.")

Later that day soldiers at another military checkpoint between San José de Apartadó and the community of La Unión (part of the Peace Community) reportedly detained a young boy and asked his name. They reportedly noted his name in a book and said, "Estamos anotando estos nombres para tener toda la lista de los guerrilleros. Todo el mundo aquí es guerrillero." ("We're writing down these names to have a list of all the guerrillas. Everyone around here is a guerilla.")

On 5 December five soldiers reportedly entered the house of Rodrigo González a member of the Peace Community and ordered him to tell them the whereabouts of the guerrilla forces. They said that the Peace Community was a guerrilla community.

The paramilitary incursions in the Cacarica River Basin and the army accusations against the Peace Community of San José de Apartadó of being a guerrilla community raise serious concerns for the safety of these communities. Both these communities have called on both sides in the conflict to respect their right to life and their right as civilians not to be drawn into the conflict. The security forces and their paramilitary allies have repeatedly accused the

returning displaced communities of the Cacarica and San José de Apartadó of being linked to guerrilla forces, these accusations have left the civilian population exposed to continued threats and attacks.

FURTHER RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish, English or your own language:

- expressing serious concern for the safety of the recently returned displaced communities in the Cacarica River Basin area, and for the San José de Apartado "Peace Communities" in Chocó, after paramilitary gunmen attacked the settlement of Villa Hermosa-La Raya;
- urging the authorities to take action to protect the communities, in line with the communities' own wishes;
- expressing concern that the government and its security forces have taken no effective action against paramilitary groups in the department of Chocó, despite repeated government commitments and UN recommendations to combat and dismantle these groups;
- calling for a full and impartial investigation into links between the security forces and paramilitary groups operating in the department of Chocó, with the results made public and those found responsible for supporting and participating in such groups brought to justice.
