IMPRISONED DOCTOR

Dr Omar DEL POZO Marrero

Dr Omar del Pozo, a 47-year-old Cuban physician, is currently serving a 15-year prison sentence in Combinado del Este Prison, Cuba, for "revealing state secrets". Amnesty International believes that he is a prisoner of conscience, imprisoned solely as a result of his political and human rights activities. The organization appealed for his release in 1995 (see AMR 25/10/95, 31 August 1995), and is again calling for his immediate and unconditional release. Amnesty International has received further information about the state of health of Dr Omar del Pozo. According to latest reports, he is suffering from malnutrition, leading to the loss of almost all his hair, several teeth, as well as body mass. He continues to suffer from high blood pressure, apical abscesses, a stomach ulcer, as well as heart and kidney problems.

While in prison Dr del Pozo has reportedly suffered harsh treatment, adding to a deterioration in his physical condition. Until June 1995, he spent most of his time in Quivicán, a maximum security prison in Havana, where there are reports of poor food, excessive heat and sanitary conditions. Dr del Pozo has gone on hunger strikes and has been placed in punishment cells at various times, on one occasion for four months, where he was not allowed any family visits, reading materials or exercise. He was moved to a military hospital on 1 June 1995 where he reportedly did not receive any medication for his medical problems for more than a week.

After five weeks, at the beginning of July 1995, he was transferred to Guanajay Prison. According to Dr del Pozo's family, while in Guanajay his physical condition did not improve and lesions appeared on his face. In February 1996 he was transferred to Combinado del Este Prison, where he remains.

Amnesty International is urging the immediate and unconditional release of Dr del Pozo and is seeking assurances that he have access to adequate nutrition and any necessary medical care.

Background

Dr Omar del Pozo Marrero, president of the *Unión Cívica Nacional* (UCN: National Civic Union), a non-violent opposition group, was arrested on 19 April 1992 at his home in

Havana. Two other people, Carmen Arias Iglesias and Victor Rinaldo Infante, were arrested at around the same time. All were initially held at the State Security headquarters at Villa Marista but no information was available concerning the charges to be brought against them until a few days before their trial took place on 1 August 1992. They were tried together with a member of the State Security police, Sub-Lieutenant Julio César Alvarez, in a military court. All were accused under article 95 of the Penal Code, which deals with the revelation of state security secrets.

Dr del Pozo and Victor Rinaldo Infante were convicted under article 95 of the Penal Code and sentenced to 15 and 13 years' imprisonment respectively. Carmen Arias was convicted of being an accomplice to the actions of the two civilians and sentenced to nine years' imprisonment. Following a visit to Cuba by US Congressman, Bill Richardson, she was released in February 1996, on condition that she go into exile abroad.

[In December 1996 Victor Rinaldo Infante was transferred from Combinado del Sur Prison to Agüica Prison. On 21 January 1997 he was tried in case no. 20/97 and sentenced to an additional one year's imprisonment, charged with "*desacato*" ("disrespect"). This was reportedly because in December 1996, while held in Combinado del Sur Prison, he protested when a prison official beat another prisoner. Amnesty International considers this new sentence simply as a further way to punish him for his views relating to human rights and continues to call for his immediate and unconditional release as a prisoner of conscience.]

Summary

Recommended Actions

Letters from medical professionals, preferably written in Spanish or your own language, should be sent to the addresses below:

- urging that Dr. Omar del Pozo be immediately and unconditionally released on the grounds that he is a prisoner of conscience;
- expressing concern at his state of health; asking for details of his current situation and for details of any medical care he is receiving;
- urging that while in prison he have access to adequate nutrition and medical care.
