Amnesty International remains concerned about the legal situation and the state of health of Amador Blanco Hernández who is on hunger strike in protest of his arrest. He had reportedly been convinced by a doctor to call off his hunger strike, but decided to resume it, apparently because the authorities still intend to bring him to trial on a charge of enemy propaganda. Since 18 February 1993, he is said to have been ingesting only water and his condition is said to have deteriorated.

Amador Blanco Hernández is being held in the infirmary at Santa Clara Provincial Prison but it appears that the authorities intend to transfer him at some point to La Pendiente Prison, also in Santa Clara, to await trial. In a message dated 20 February 1993 to the Secretary-General of the United Nations, which was smuggled out of the prison, he said that he was told on 19 February 1993 by the Jefe de Seguridad de Cárceles y Prisiones del Departamento de Seguridad del Estado (DSE), Head of Prison Security of the Department of State Security, that he would be force fed if he did not give up his hunger strike. He also wrote that he believes the prosecution intend to request a prison sentence of eight or ten years, he maintained his innocence and that he intended to carry on his hunger strike whatever the consequences ("tengo la firmeza de continuar la huelga de hambre hasta las últimas consecuencias").

From the information so far available, Amnesty International believes Amador Blanco Hernández to be a prisoner of conscience, detained solely on account of his non-violent activities in support of human rights. He was arrested at his home in Caibarién, in the province of Villa Clara, on 10 December 1992 and taken to the DSE headquarters in Santa Clara but was subsequently transferred to Santa Clara Provincial Prison under investigation on a charge of enemy propaganda. As far as Amnesty International is aware, he has had no access to a lawyer but has been permitted family visits. He suffers from asthma and high blood pressure.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes and airmail letters either in Spanish, English or in your own language:

- urging the immediate and unconditional release of Amador Blanco Hernández on the grounds that he is a prisoner of conscience detained solely on account of his non-violent activities in support of human rights;
- expressing concern that he has reportedly resumed his hunger strike in protest at his arrest;
- noting that he suffers from asthma and hypertension and seeking information on his present state of health;

- seeking assurances that he has access to proper medical attention and is receiving all the medical care he requires;
- urging that he be granted immediate access to a lawyer of his choice.
